

2. It must be typed in MS Word Format (Font: Times New Roman, Font Size: 12 for text and 1.0 line spacing for footnotes).
3. Word limit for Abstract: 300-350 words
4. Word Limit for Full Paper: 4000-8000 words (including footnotes)
5. The margins are to be 1", text is to be justified and OSCOLA format of citation is to be used.
6. Plagiarism beyond 20% will lead to disqualification.
7. Presentation can be done using Power point Presentation.
8. There is no Fee for registration and paper presentation.
9. The copy of the abstract and full paper along with the Power Point Presentation are to be mailed to: aman.sharma@nimsuniversity.org
