- The cover page of the manuscript must contain the Title of the Paper, Author's Name, Mailing Address, E-mail Address and Acknowledgements, if any.
- References should be given at the end of the paper and should be as per the APA style
- All notes must be serially numbered and given at the bottom of the page as footnotes.
- In case of Website References, the entire URL should be provided by the authors.
