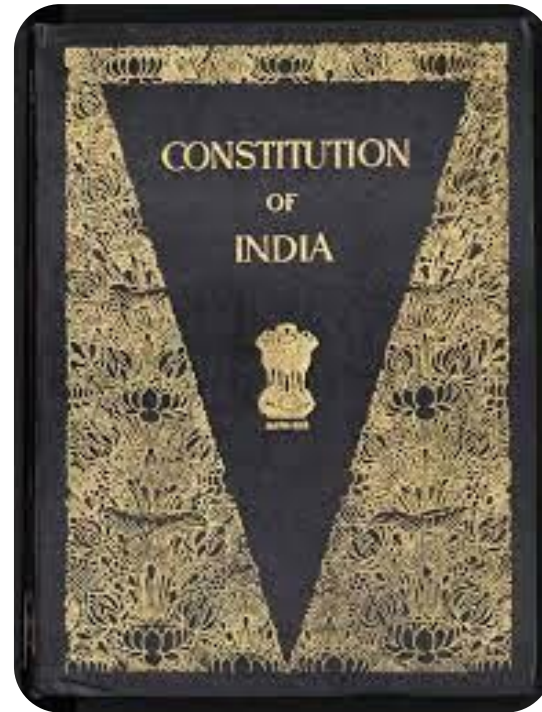

- ❑ *The submission must be attached in '**.pdf**' format only mentioning the participant's full name.*

REGISTRATION RULES



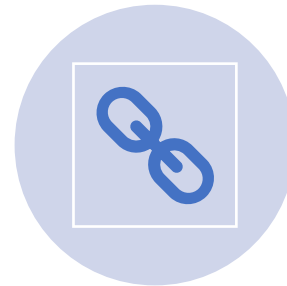
Registration is **FREE** and co-authorship is allowed for up to two participants only.

Certificate/Cash Prize will be awarded only when article is submitted on the due date.



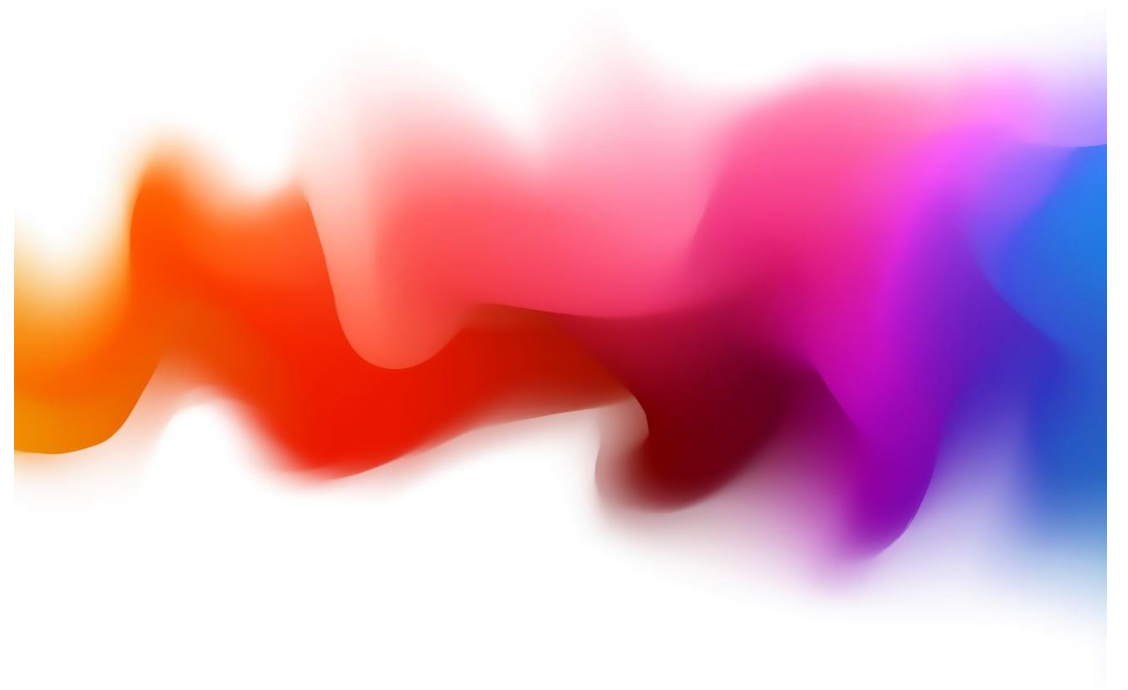
