ELIGIBILITY AND TEAM COMPOSITION:-

- The competition is open to all students enrolled bona fide on a regular basis in a 5 Year or 3 Year law course or its equivalent, conducted by any recognized College/ Institution/ University.
- Each team shall comprise three members, two of whom shall be designated as speakers, and the third member shall be designated as a researcher.

LOCATION :-

The Competition will be conducted virtually on **14th & 15th March, 2024**. The final round will be conducted on **March 30th, 2024**, in physical mode at FIMT Campus, Kapashera, New Delhi 110037.

REGISTRATION PROCEDURE :-

- Each team must register by filling up the Registration Form with all the necessary details and by paying the registration fees as provided in the rules of competition & shall complete registration on or before **10th February, 2024 (11:59 PM)**
- A scanned bonafide letter for participation, issued by the appropriate authority of the Team's recognized College/ Institution/ University shall be uploaded on the google form.
- Once a team registers by completing the formalities given in the rules of the competition, a code (herein after "TEAM CODE") shall be assigned to the Team by **15th February, 2024**.

SUBMISSION PROCEDURE:-

- Each Team shall send a soft copy of the Memorial for each side in PDF and Microsoft Word(.docx/.doc) formats, via e-mail, on or before **5th March, 2024 (11:59 PM)** to **fimtsolmootcourt@gmail.com**
- Any soft copy submission made after **5th March, 2024 (11:59 PM)** will be considered a late submission and shall be penalized with 1 mark for each day of delay.

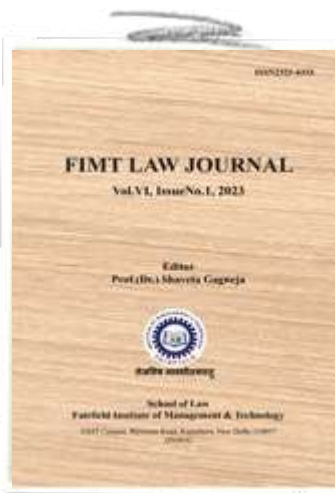

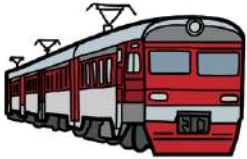

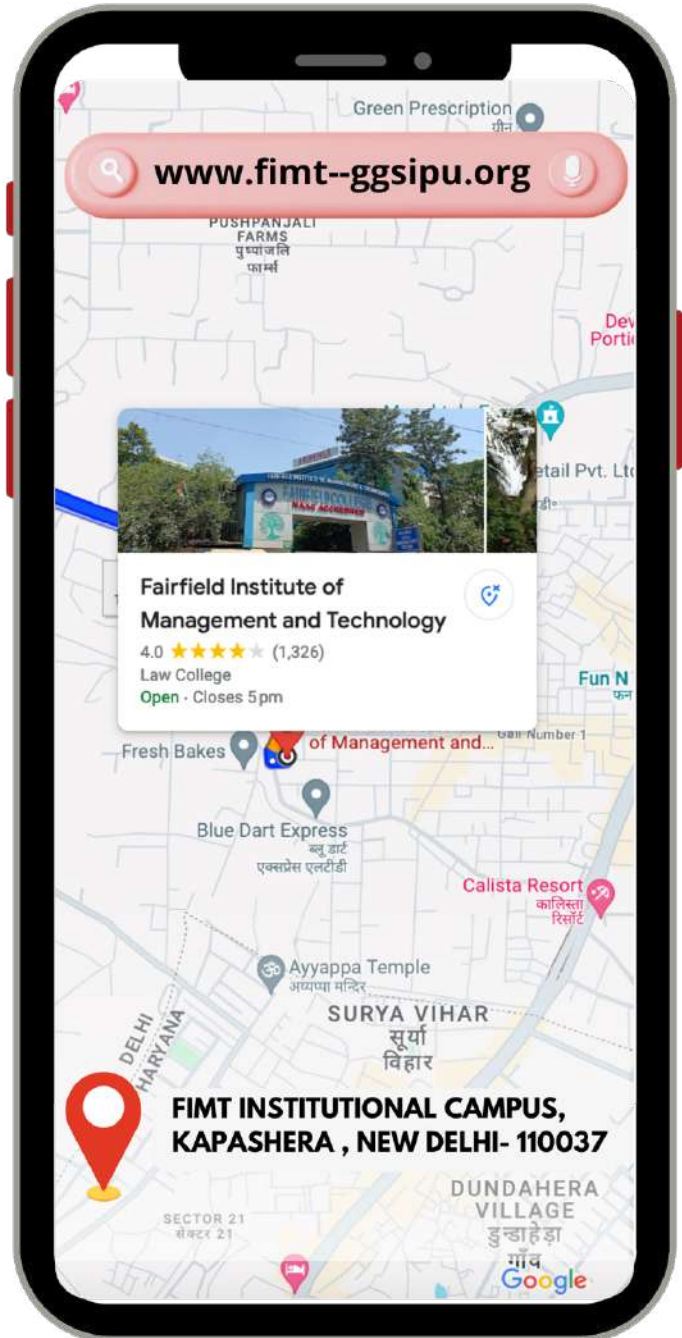
