## Rules of the Competition

**Language :** The language of the Competition shall be English.

**Eligibility Criteria:**

Law schools/Colleges/Institutes/ Universities, recognized by the Bar Council of India, are eligible to participate. The participants should currently be pursuing their degree in law i.e., Three Year/Five Year Law/LLM Courses, Students who have completed their law courses are not eligible to participate in the competition.

Only one team can register from a particular law school/College/Institution/ University to participate. There shall be two speakers and one Researcher designated for each team. In case of illness of the designated speaker, the researcher may be allowed to argue for the team with prior permission of the Committee.



### Registration :

The Participating team shall duly fill the Registration Form provided along with the official rules and send it along with a Registration fee of Rs. 2000/- (Rupees Two Thousand only) without accommodation and Rs. 3000/ with accommodation. The Registration fee shall be sent through Online Payment.

The last date for receiving the registration form with fee shall be 10th April, 2024.

The participants are required to submit one passport size photograph of each team member along with the registration form.

Each team shall be allotted a Team Code on the receipt of registration fee and form. The Draw of Lots for the Preliminary rounds shall be drawn by the QSL Debating Society on 4th May, 2024 and the opponent memorial shall be mailed to the respective teams after Draw of lots. The name of the Institution shall not be disclosed at the time of submission of memorials. Any such disclosure shall lead to disqualification.

### Written Submissions/Memorials

- ❖ All participating teams shall submit 6 sets of written memorials. The cover page of memorials for the Prosecution shall be in Blue and the Defense shall be in Red.
- ❖ The teams shall not indicate their names or the names of their college or the university on memorials. For all communications purposes, only the team code shall be specified.
- ❖ The team code allotted to all teams shall be indicated at top right corner of the memorial, which will be communicated by way of E-mail.
- ❖ All participating teams must submit a soft copy of their memorial in PDF format, for both sides by 11:59 PM. IST on or before 20th April, 2024. Hard copies must be exact prints of the soft copies. Non-compliance with this rule would entail negative marking which may also attract disqualification. Decision in this regard shall be taken by the Committee.

### The written memorials shall conform to the set standards

Written memorials shall be printed on white A4 size paper with black ink and neatly bound. No plastic divider should be used in the memorials. The font of the body of the Memorial must be Times New Roman, size 12, with 1.5 line spacing and the font-size of footnotes, if any, must not be less than size 10.

Blue Book mode of citation (20th Edition) must be followed. Each page must have a margin of at least an inch on all sides. The Memorial should not exceed 25 typed pages (not including the Cover Page) and shall consist of the following parts:

- a) Cover Page
- b) Table of Contents
- c) List of Abbreviations
- d) Index of Authorities
- e) Statement of Jurisdiction
- f) Statement of Facts
- g) Issues Raised
- h) Summary of arguments
- I) Arguments Advanced (not Exceeding 15 pages)
- j) Prayer

## Structure of Rounds

### ❖ Preliminary Rounds

There shall be two preliminary rounds on 4th May, 2024 and every team shall be given the opportunity to argue on each side. The Draw of Lots for the Preliminary rounds shall be drawn by the Committee on 4th May, 2024. Each team shall get a total of 30 minutes to present their case and shall include the time for 'rebuttal' and 'Sur-rebuttal'. Any extension of time beyond the specified period shall be subject to the discretion of the judges. The division of time between the speakers is the discretion of the team members, subject to a maximum of 20 minutes for one speaker. Before the commencement of each round, each team shall indicate to the 'Court officer' as to how they wish to allocate their time. At the end of the preliminary rounds, the top 8 teams will qualify for the Quarter Finals. The top 8 teams will be selected on the basis of scores. For the purpose of calculation, the marks awarded for the written submissions shall be added to the oral round score and a team will be evaluated for 300 Marks in the round. If the situation of tie still persists, then only the total oral marks of the teams from both sessions will be considered. The team with the higher score in the oral rounds will advance to the Quarter Finals. If the situation of the tie still persists, then it would be resolved by flip of a coin.

### ❖ Quarter-Finals

The Quarter Finals will be held after the completion of the preliminary rounds i.e., on 4th May, 2024. The Quarter Finals shall be knock-out round. A team will be credited with a win in the Quarter Finals if their total marks are higher than its opponent's team. The side to be presented by the team shall be determined by way of draw of lots with the teams picking the lots after the completion of the preliminary rounds. Each team shall get a total time of 30 minutes to present their case and shall include the time for 'rebuttal' and 'Sur-rebuttal'. The division of time between the speakers is the discretion of the team members, subject to a maximum of 20 minutes for one speaker. Before the





commencement of the round, each team shall indicate to the 'court officer' as to how they wish to allocate their time

### ❖ **Semi-Finals**

The Semi-Finals will be held on 5th May, 2024. The Semi-Finals shall be knock-out round. A team will be credited with a win in the Semi-Finals if their total marks are higher than its opponent's team. The side to be presented by the team shall be determined by way of draw of lots with the teams picking the lots after the completion of quarter-finals rounds. Each team shall get a total of 40 minutes to present their case. This time will include the time for 'rebuttal' and 'Sur-rebuttal'. The division of time between the speakers in the discretion of the team members, subject to a maximum of 25 minutes for one speaker. Before the commencement of the round, each team shall indicate to the court officer as to how they wish to allocate their time.

### ❖ **Final Round**

The final round will be held on 5th May, 2024. A team will be credited with winning the Final if their total marks are higher than its opponent team. Each team shall get a total of 45 minutes to present their case. This time will include the time for 'rebuttal' and 'Sur-rebuttal'. The division of time between the speakers is the discretion of the team members, subject to a maximum of 30 minutes for one speaker. Before the commencement of the round, each team shall indicate to the 'court officer' as to how they wish to allocate their time.

### Researcher Test

The Researcher Test shall be conducted on Day 1 of the Competition.

- A. The test shall be for duration of Forty-Five (45) minutes only. The test will be based on MCQs (Multiple Choice Questions) of thirty Marks (60) questions (Multiple Choice Questions).
- B. If a team comprises of three (3) members, then ONLY the Researcher is eligible to take the test. Researcher test marks will NOT be added up in the marking criteria.

### Dress Code

The official Dress Code for the Competition is as follows:

- ❖ Gentlemen: Black Trousers, White Shirt, Black Blazer, Black neck tie, and Black formal shoes;
- ❖ Ladies: Black Trousers/Skirt, White Shirt, Black Blazer, Black neck tie and Black formal shoes (or) White Salwar Kameez, Black Blazer, and Black Formal shoes.

Any dispute about the Moot Court Competition shall be referred to the Committee before the end of the competition. In all the matters of complaints or disputes, the decision of the Committee shall be final.

### Accommodation:

Participants from outstation shall be provided shared accommodation by the university for the duration of the competition. Only the registered three members of the team shall be provided accommodation. The team shall make their own arrangements for any extra members. All teams shall be provided accommodation from the evening of 3rd till 6th morning

## MOOT PROPOSITION

1. In the sovereign nation of Junaantu, renowned for its commitment to technological advancements and startups, the constitutional framework nurtures innovation. The Constitution of Junaantu acknowledges the pivotal role of startups in propelling economic growth and fostering technological breakthroughs. Under Article 19, the fundamental right to trade and engage in business is enshrined, providing a robust foundation for entrepreneurial endeavors. The constitutional ethos of Junaantu places a premium on fostering a competitive business environment while safeguarding the rights of individuals and startups alike.

2. While some startups are booming, many face a tough time. The big tech companies own a large part of the market. This makes it hard for startups to compete. The startup scene in Junaantu is lively, but the dominance of traditional players poses a threat to innovation. In order to tackle this and prevent monopoly the Competition Act, 2002, takes center stage as the regulatory framework addressing concerns of anti-competitive practices.

3. In the vibrant landscape of the technology sector in Junaantu, the battle for dominance and innovation unfolds among key players. Junaantu, renowned for its burgeoning tech market, witnesses the clash between Nexus Dynamics, a stalwart in smart device software, and Quantum Innovations Consortium, an alliance of tech innovators. As of 2023, Nexus Dynamics commands a considerable market share of 45%, solidifying its position as a leading force in the realm of smart device software. Not far behind, Quantum Innovations Consortium claims a competitive share of 35%, standing as a collaborative powerhouse in technological innovation. The entrance of Photon Enterprises, a dynamic newcomer, disrupts the status quo by swiftly securing 12% market share within a short span of two years. Various other smaller entities also contribute to the vibrant market.

4. Nexus Dynamics and Quantum Innovations Consortium, in their pursuit of market dominance, independently engage in agreements with various app developers. These agreements impose restrictions on app developers, preventing them from creating applications for the smart devices of other companies. This strategic move by both entities significantly influences consumer choice and impacts the competitive landscape, particularly affecting smaller players like Photon Enterprises.

5. Photon filed a complaint with the Competition Commission of Junaantu ("CCW"), alleging anti-competitive conduct by Nexus and Quantum Consortium. The core of the complaint revolves around the "exclusionary agreements" entered into by both entities, limiting app developers' ability to create applications for the devices of other companies. While there was no accusation of collusion or cartelization between Nexus and Quantum Consortium, the complaint argued that both were dominant players in the smart device software market of Junaantu, abusing their position to the detriment of smaller players like Photon, thereby negatively impacting overall competition.

6. In support of the complaint, market research reports highlighting Nexus's 45% market share and Quantum Consortium's 35% were submitted. Photon sought



directions from the CCW to penalize Nexus and Quantum Consortium for abusing their dominant position and to restrict them from entering into or acting upon agreements that limit app developers from creating applications for the devices of other companies.

7. Simultaneously, Photon filed an application for interim relief, aiming to restrain Nexus and Quantum Consortium from enforcing agreements restricting app developers from creating applications for the devices of other companies. Photon argued that without interim relief, smaller players would face extinction, being forced to exit the market within a few months.

8. The CCW rendered a decision rejecting the complaint, stating that the data presented by Photon indicated a lack of a single dominant entity in the smart device software market. Instead, it showcased fierce competition between Nexus and Quantum Consortium, portraying them as business rivals rather than a dominant force. The concept of more than one dominant entity in the same market was deemed foreign to the Competition Act, 2002. Consequently, the complaint was dismissed, and the case closed. The application for interim relief was also dismissed.

9. Undeterred, Photon appealed the CCW's decision before the Competition Appellate Tribunal ("COMPAT"). The COMPAT, acknowledging that the agreements restricting app developers could be viewed as restrictive and anti-competitive, observed that further investigation was required to ascertain if there was a violation of the Act or if the restrictive clauses had a commercial justification.

10. Nexus and Quantum Consortium highlighted their significant market shares and emphasized that nothing in the Competition Act, 2002 prohibits the existence of more than one dominant enterprise in the same market. Photon argued that the regulator should not turn a blind eye if two entities engage in abusive practices. Photon invokes Article 19 of the Constitution of Junaantu, emphasizing the fundamental right to trade. They contend that the restrictive agreements imposed by Nexus and Quantum Consortium impede their freedom to trade, hindering their growth and innovation. Photon asserts that, as a startup, they are essential contributors to the burgeoning tech ecosystem and should be afforded protection against anti-competitive practices that stifle their ability to compete.

11. The COMPAT directed the Director General to investigate and present a report to the CCW. Additionally, it restrained Nexus and Quantum Consortium from enforcing agreements restricting app developers from creating applications for the devices of other companies until the final order of the CCW.

12. Nexus and Quantum Consortium filed an appeal before the Supreme Court of Junaantu against the order of the COMPAT. It was contended that by simply expressing a possibility of violation without any definite finding, the COMPAT had



failed to arrive at any prima facie view of violation, which would warrant investigation. It was also argued that the present case was not a fit case for grant of interim reliefs and that Photon had failed to make out a case for grant of such reliefs. The agreements had a commercial justification, and Photon was attempting to use the regulatory route to impede the business of established and efficient market players. Further the legal issue of whether the Act recognizes the concept of more than one dominant undertaking was placed before the Supreme Court of Junaantu.

13. In the heart of Junaantu's technological renaissance, this case stands as a pivotal moment, unravelling the complexities of competition in an era where innovation and dominance walk hand in hand. The legal discourse now rests in the hands of the Supreme Court, as it navigates through the intricate intersections of competition, innovation, and regulatory oversight in the dynamic landscape of Junaantu's tech-driven future. As the legal saga unfolds before the apex court, the interpretation and application of justice, good conscience, and equity will play a pivotal role in determining the fate of Nexus Dynamics, Quantum Innovations Consortium, and the burgeoning startup, Photon Enterprises.

Participating teams have to frame their issue and sub-issues accordingly.

(Note: The laws of Junaantu are pari-materia to that of India)
