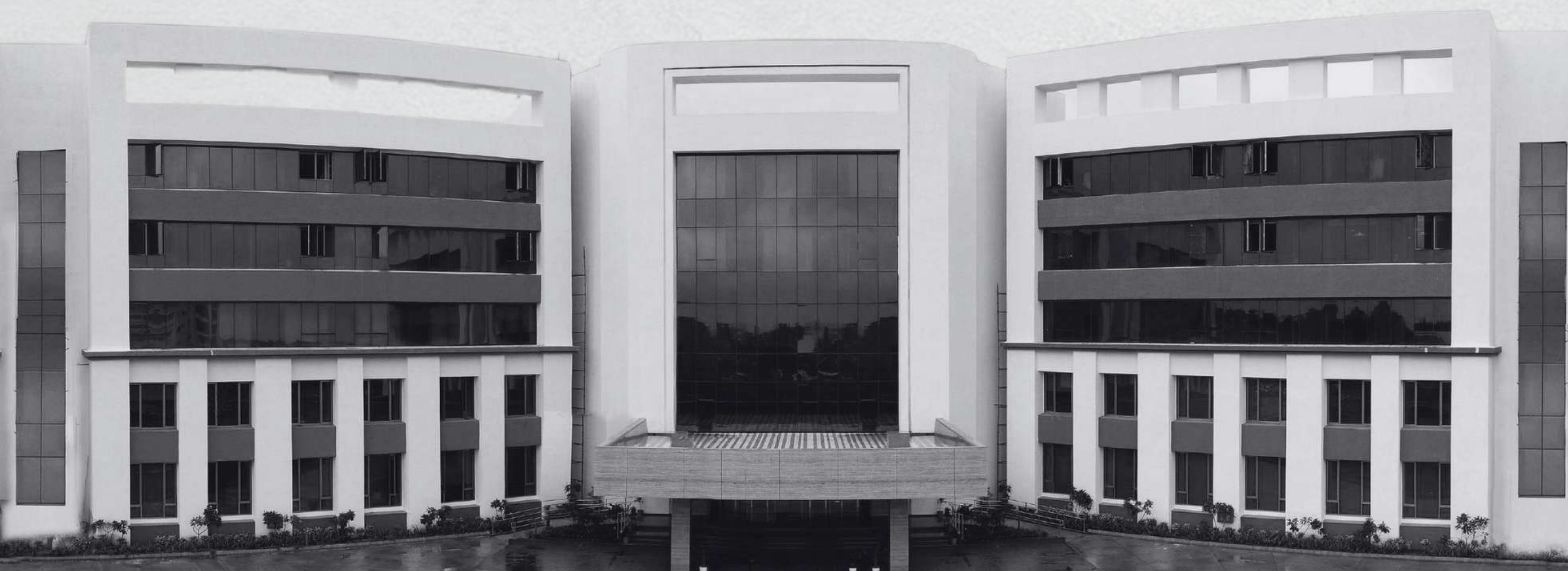

FROM THE DESK OF ASSOCIATE DEAN

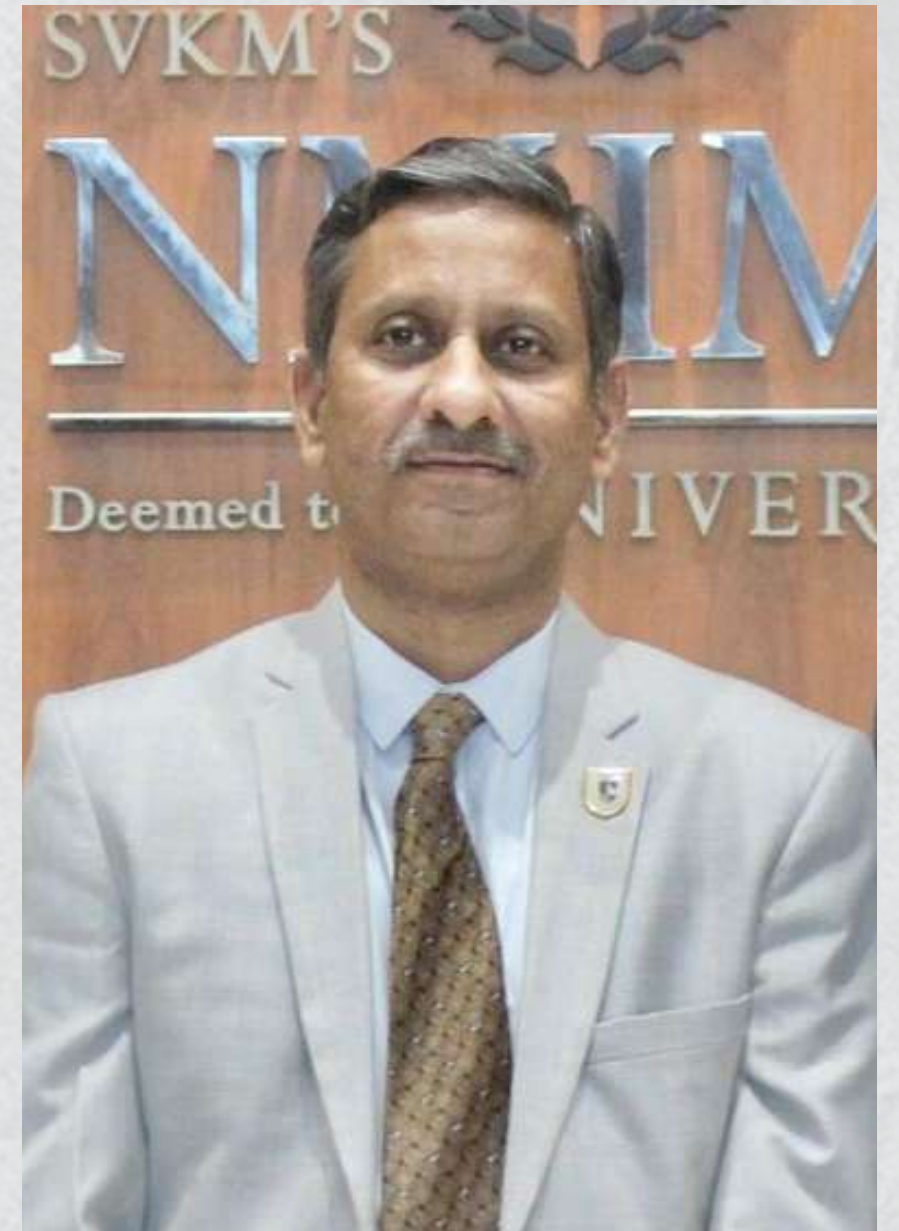
