# ROUNDS OF THE COMPETITION

# LANGUAGE

The language of the competition will be English.

# ELIGIBILITY

1. Students pursuing 3/5 year Law Course are eligible to participate in this competition.

2. Only one team can participate from each institution.

## TEAM COMPOSITION

Each team of the competition shall consist of the following members-

Each team shall consist of three (3) members. Teams shall have two

(2) Speakers, & one (1) researcher

All the three members of the team, should belong to the same institute. No cross teams i.e. members of different institutes/universities, shall be allowed.

Each team should identify such speakers and researchers at the time of registration. The researcher may be permitted to argue as speaker only in case of illness or any unforeseen event, but a written permission of the Moot Court Convener in such case shall be mandatory.

There shall be no circumstance whatsoever that a team consisting of more than 3 members be allowed to participate. No observer/ additional member can be part of a team in any capacity.

There shall be no substitution of any team member after a team has submitted its Registration Form, except with the permission of the Organizers.

### DRESS CODE

The participants shall adhere to following dress code while presenting in virtual court room during the Competition.

Girls: White Shirt, Black Trouser and Black Blazer and Black Shoes.

Boys: White Shirt and Black Trouser along with Black Tie, Black Blazer and Black Shoes

Note: The participating teams shall also adhere to the above- mentioned dress code while attending the inaugural and valedictory ceremonies of the Competition.

## **Rules for Memorial**

The following requirements for memorial must be strictly followed by the participants-

1. AII memorials submitted for all purposes of the Competition shall strictly adhere to the rules of the Competition. Each Team participating in the Competition must prepare oneMemorial on behalf of Petitioner(s)/ Appellant(s) and one on behalf of the Respondent(s).

Further teams participating online will submit only soft copies of the Memorials from each side and those who are participating in Person has to submit Softcopies as well as Hardcopies of the memorials

2. Appellant memorials are required to have a Blue cover and Respondent memorials are required to have a Red cover. The memorials shall not contain any form of identification apart from the team code. If any such identification or mark, symbol, etc. which has the **effet** of identifying the team is found on the memorial, then it shall result in instant disqualification. A penalty of 1 mark shall be levied in case the memorial is submitted in any other format or as a multiple file by the team.

While sending the softcopy of the memorials in PDF format, please name the file pertaining to the Respondent as R accompanied by the team code and name the file pertaining to the Petitioner as P accompanied by the team code. For example, Respondent of team 06 should name the PDF file as R06.

#### **2. TEAM CODE:**

The team code must be ascribed on the top right corner of the cover page.

### **3. CONTENT SPECIFICATIONS:**

The following content specifications must be strictly adhered to-

a. Font and Size (General) - Times New Roman, 12 pts

b. Line Spacing (General) - 1.5 lines

c. Font and Size (Footnotes)- Times New Roman, 10 pts

d. Line Spacing (Footnotes) - Single line

e. Page Margins -1 inch on all sides

f. The citation should be in compliance with the 20th edition of Bluebook. Speaking footnotes or Endnotes are not allowed.

## DRAW OF LOTS

The Draw of Lots will determine from which side the participant present their arguments i.e., Petitioner/Plaintiff or Respondent/Defendant. The Draw of Lots will also decide which team you will be competing against (There will be no predecided fixtures). The team codes will be provided to teams before the draw of lots but their sequence of participation will be decided there on.

## ORAL ROUNDS

#### A. PRELIMINARY ROUNDS

a. Each team will get a total of 20 minutes to present their case.

b. Each speaker should speak for a minimum of 8 minutes.

c. The time stated above includes the time required for rebuttal and surrebuttal. However, the maximum time taken for

rebuttal and surrebuttal shall not exceed 3 minutes.

Each team shall present one side in this round. Each team will represent Petitioner's side or the Respondent' side, in the sequence determined under Draw of Lots. The top 10 team based on their Total Preliminary Score in the Preliminary Round shall qualify for theSemi-Final Round. Total Preliminary score does not include the memorial score.

#### **B. SEMI FINAL ROUNDS AND FINAL ROUND**

a. Each team will get a total of 30 minutes to present their case.

b. One speaker shall not exceed 15 minutes of the total time.

c. The time stated above includes the time required for rebuttal and sur-rebuttal.

However, the maximum time taken for rebuttal and sur-rebuttal shall be not more than 5 minutes. This will be a knockout round.

### C. MARKING CRITERIA

Maximum scores for the oral rounds shall be 100 points per speaker, and which shall be judged on the following criteria:

#### **D.** General Online Rules: for online participants

**1.** The oral rounds shall be conducted online on a live video conferencing platform. The details of the platform shall be shared to the teams via mail.

**2.** An Invitation link of the meeting shall be sent to participants on their respective email IDs submitted by them in Registration Form.

**3.** The Participants are expected to be seated in a quiet space free from any echo and isolated from any form of disturbances.

**4.** The Participants must make sure that the Background is plain and sober which does not disturb the judges. Preference will be given to a White background. The participant should be visible in Portrait Mode/ Vertical Manner.

5. The participants should only use their team code as their username while joining themeeting room.

6. All participants should be online at least ten (10) minutes prior to the commencement of their round.

7. Following are the mandatory system requirements to participate in the competition:

a. Computer/Laptop with a well configured web camera.

b. A stable Internet Connection

c. Headphones or Earplugs that have a working microphone.

8. While in a round, the participants must have their camera on all the time.

**9.** The participants should unmute their microphone when it is their turn to present their arguments, speak or when asked by the judge or the Organizers to do so.

**10.** The participants should not use group text feature of the Organizer's hosting platform to communicate with one another.

**11.** No screen sharing is allowed.

**12.** The Organizers shall not be responsible for any loss due to slow or non-functional Internet Connection during the Competition.

13. In any case whatsoever, the decision of the Organizers shall be final and binding

### **Guidelines for the offline Participants**

- 1. It is mandatory for Participants from Pune Law Colleges to participate in competition in offline mode only
- 2. Online Registration is mandatory
- 3. All the offline participants should submit the memorial online at first instance on given date. i.e. on 5<sup>th</sup> April 2024. The offline participants should submit the hard copy on the day of Competition with students coordinators at Law Department (TMV Campus) at the time of reporting on 12<sup>th</sup> April 2024
- 4. Offline Participants from Pune, Out of Pune and out Maharashtra should report at Tilak Maharashtra Vidyapeeth Campus minimum 1 Hr prior to Inaugural session on 12<sup>th</sup> April 2024.at 9.00 am
- 5. Participants coming from outside Pune or Maharashtra should communicate their date and time of arrival at Pune with students coordinators in 10 days advance, so that necessary arrangements can be done.
- 6. Accommodations and other facilities will be provided to the students participants on first come first serve basis.

The organizers shall have the rights reserved over all the audio, video or submitted memorials and compendium and the organizers are free to use or dispose them off in themanner they deem fit.

## AWARDS AND CERTFICATIONS

1. Winner of the Final Round will be given the "Best Team" certificate, memento and a cash prize of Rs 7000

2. Runner-up of the Final Round will be given the "Runner Up" certificate, memento and a cash prize of Rs 4000

3.Team with the highest memorial scores will be given the "Best Memorial" certificate, memento and a cash prize

of Rs 1000

4. "Best Mooter" award will be given the "Best Mooter" certificate, memento and a cash prize of Rs 1000

In addition to the above, e-certificates will be issued to all the participants within one week from the valedictory function and no prior request shall be entertained in any case.

### ANONYMITY

The counsels shall not state their names during the oral rounds and must use the assigned team code for all correspondence. All team members must refrain from disclosing the identity of their institutions at any time and in any manner during the entire Competition. Non-compliance with this Rule will result in immediate disqualification of the team.

# FINALITY OF DECISION

The decision of the judges with regard to the outcome of the rounds shall be final. For all purposes and in any dispute, the decision of the Convener of the Organizing Committee of the Competition shall be final and binding.

## **MOOT PREPOSITION**

The Republic of Indus Land is the most ethnically and religiously diverse country in the world. The danger of communal conflicts is ever-present and unlikely to wane anytime. In March 2019 reports about Love Jihad were reported. The news report stated that there has been 3,000- 4,000 conversions in the past four years in Indus Land. Various High Courts from across the country have stated that religious conversion is not a casual matter. In 2014, the High Court of Udayan Pradesh stated in a judgement that if conversion "is resorted to merely with the object of creating a ground for some claim of right" it would be "a fraud upon the law".

Meera, a Hindu residing in Pumbai, Ashfaq a Muslim residing in Lumnow, met first time on a dating app, where they started liking each other. Months after knowing one another they fell in love with each other. In the year 2021 they started residing in a live-in-relationship for a few months and later decided to get married under the Special Marriage Act, 1956. Meera's parents opposed the marriage, as it was an inter-religious marriage, however, Ashfaq's parents accepted their marriage.

Subsequently, Meera decided to convert to Islam, out of her love and respect for Ashfaq's family. The marriage occurred on 10th January 2022. On 17<sup>th</sup> January, 2022 Meera underwent the ceremony of conversion from Hinduism to Islam. The couple went to Ashfaq's home in Lumnow on 11th February, 2022. They were greeted warmly by Ashfaq's family. After few weeks of marriage, frequent quarrels and fights due to her belongings found containing pictures of idols of her earlier

faith. Meera, sustained some injuries and bruises on her arms and legs. She immediately in a feet of rage, sent pictures of the injury marks on her legs and hands through whatsapp to her parents.

An increase in Covid cases in the State led to a two-week lockdown which was announced on 15th March 2022. Due to which parents could not visit her daughter to inquire her welfare. Meanwhile, Meera's brother met with an accident and was put on bed rest on account of multiple injuries. Meera requested Ashfaq's family to let her visit her brother but she was not allowed to go under the pretext of reasons such as the risk of attracting Covid and limited transportation options. In May 2022 Meera called and asked her parents to pick her up from Ashfaq's home. Upon knowing about the details of their marriage and the conversion, they suspected that Ashfaq and his family had coerced Meera to convert into their religion and were now wrongfully restraining her against her will. Subsequently, with special travelling pass they travelled to Lumnow and they took her to nearest Police Station and they filed an FIR in Rainbow Police Station against Ashfaq's family under Section 498A/S. 340 of IPC as well as under the Udayan Pradesh Prohibition of Unlawful Religious Conversion Act, 2021. Information was sent to the Malawa police station situated near the residence of Ashfaq's family, and soon, his family members were arrested on 20th May 2022. However, the Magistrate denied bail to Ashfaq's family and issued a nonbailable warrant against Ashfaq under section 498A. As a result, Ashfaq and his family preferred a Special Leave Petition before the Supreme Court and filed a writ petition challenging the validity of the Udayan Pradesh Prohibition of Unlawful Religious Conversion Act, 2021.

Considering the substantial questions of law relating to interpretations of the Constitution, both the petitions are clubbed and scheduled for hearing before a Constitution Bench of the Supreme Court. The matter is listed for hearing on 12<sup>th</sup> April 2024.
