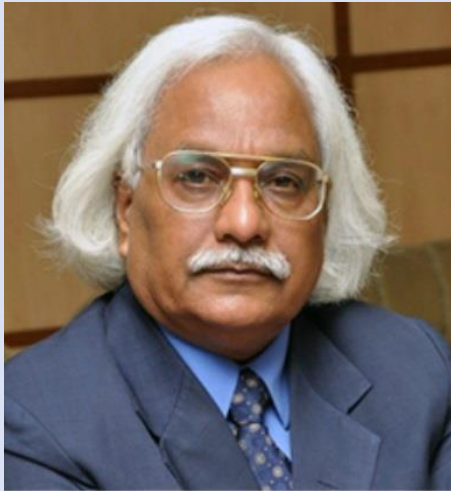

4th Amity National Moot Court Competition, 2019



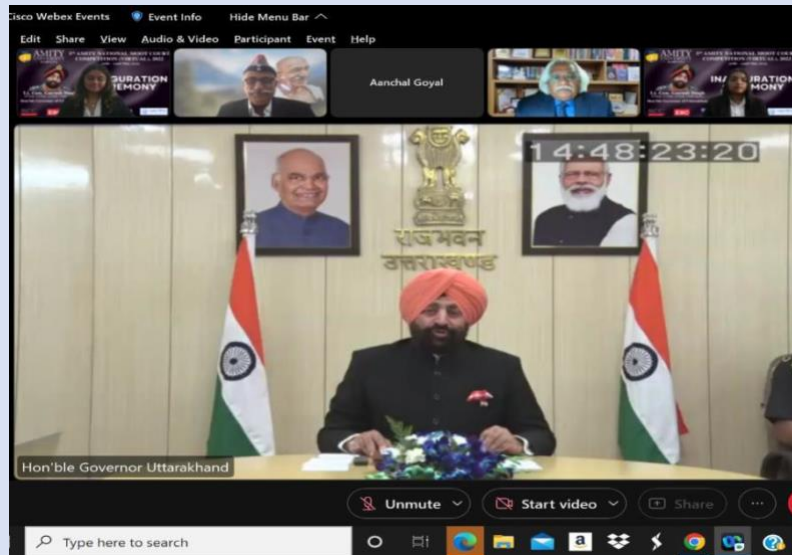

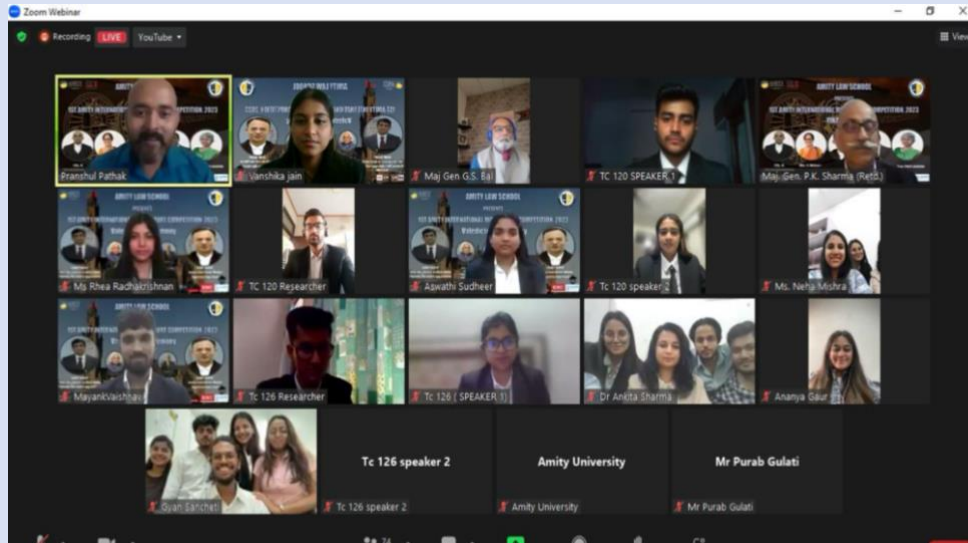

MOOT PROPOSITION

1. There was once a country named as the *United Republic State of Sover* (hereinafter referred to as "*URSS*"). It was a huge country of many regions. The nation was a super power. It had developed modern weapons which included nuclear weapons too. The country was economically sound and had made significant inroads in various other fields too. The URSS had a continuous tussle with the *United Region of Anreeca* (hereinafter referred to as "*URA*") for becoming the super power country of this world. URA was one of the oldest democracies of this world and a developed country too.
2. During the fag end of 20th Century and in a quest to become a superpower, URA through indirect involvement created a split in the URSS. *URAINÉ* and *ROOS* were two regions of URSS and they shared borders too. Many regions of *URAINÉ* had people who were culturally associated with *ROOS*. *ROOS* was the largest of the regions of URSS. Because of the split *ROOS* became an independent nation with a communist model of governance and a presidential government.
3. *URAINÉ* at the time of split was given the option of whether they wanted to merge with the larger region of *ROOS* or they wanted an independent country. For deciding, *URAINÉ* opted for the referendum by people of its region. Tribes of *URAINÉ* who were culturally associated with *ROOS* voted to become a part of *ROOS* but their opinion was voted out by the native people of *URAINÉ*. Consequently *URAINÉ* decided to stay independent and did not merge with *ROOS*. *ROOS* was not happy with the split of URSS and it had always dreamt of taking back its lost regions of URSS.
4. URSS was a nuclear-equipped state. The major regions in which there were nuclear weapons were *URAINÉ* and *ROOS*. *URAINÉ* after the split of URSS had the 3rd largest nuclear weapons in the world. *ROOS* feared that *URAINÉ* in the coming future could use these nuclear weapons against them also. These nuclear weapons which were there in *URAINÉ* were actually made against URA as URSS and URA were competing for the top spot in the world. Hence both URA and *ROOS* thought that it could be dangerous that such quantities of nuclear weapons are there with *URAINÉ* and they can be subjected to misuse.
5. Hence URA, *ROOS* and *URAINÉ* entered into a treaty wherein *URAINÉ* will destroy all its nuclear weapons. But *URAINÉ* put some of its demands that the nuclear weapon contains uranium and hence the price of such uranium would be paid to us by *ROOS*. Also the cost of destroying such weapons would be paid by URA. Another condition which was put forward by *URAINÉ* was that neither *ROOS* nor URA would use force or take any form of military action against them.
6. Also the territorial integrity and sovereignty of *URAINÉ* would be maintained. Also if anyone tries to breach the sovereignty and integrity of *URAINÉ* then the other will protect *URAINÉ*. Both URA and *ROOS* agreed to these conditions and the agreement was signed in 1994. In pursuant to the agreement *URAINÉ* destroyed all its nuclear weapons.

7. With the passage of time, both *ROOS* and *URA* grew in strength and *URAINÉ* on the other hand suffered lots of economic hardships. In 2000, a person named P. Vutin was appointed as president of *ROOS*. He was the former member of the armed forces of URSS. He always had the dream of regaining the lost territories of URSS. Under his leadership, *ROOS* made significant developments with the changing times. P. Vutin made changes in the law and declared himself as president of *ROOS* for the coming 30 years.
8. On the other hand, *URA* also grew economically, financially and strategically. They formed an alliance of countries which was called as "Joint Action Nations". The major condition of this alliance was that if any foreign/ enemy state targets any of the member state of this alliance then the forces of all the member states will co-jointly act against him. It is because of this clause many of the countries wanted to become member states of Joint Action Nations (hereinafter referred to as "JAN").
9. In March 2012, 9 people were caught by the *ROOS* police force. After investigation it was found out that they were ex- army officers of the State of *URAINÉ* and it was alleged that they were planning to create a civil unrest in *ROOS*. The State of *URAINÉ* admitted they were their ex-army men but denied the fact that they had been spying for the alleged purpose.
10. In May 2013, there was a civil unrest against the government of *ROOS* alleging that the authorities have become arbitrary and are not paying heed to demands and requirements of common people. They also alleged that the present government needs to be thrown out and another government should be formed. A mob killed one of the ministers of the government and few police personnel also. The intelligence agency of *ROOS* reported that the *URA*'s government has given indirect support to this protesting group. They have also been supplied arms and ammunition to carry out their activities. The state of *ROOS* made a formal allegation on the basis of this information on the State of *URA*.
11. On the other hand, there was a change in government in *URAINÉ*. The political party which came to power was supportive of native Urainians and was always against tribes that were culturally similar to *ROOS*. The Political Party also had publically raised the issue many a times that these tribes were the one who wanted to merge with *ROOS* and never wanted an independent and developed *URAINÉ* . The Government policies were also made with this intention wherein people who belonged to Native *URAINÉ* were given preference over those minority tribes which were supportive of *ROOS*. These minority tribes were termed as "Pro-*ROOS* Groups".
12. In *URAINÉ* there was a city called "*KREMA*" which was a type of island but was economically important for *URAINÉ*'s development. The major inhabitants of this area were the tribal groups which were termed as Pro- ROSS Tribal Groups. They protested against the sitting government of *URAINÉ* and their protest turned into a civil revolution in the city of *KREMA*. They said that the Urainian Government is wilfully and purposely neglecting their demands and overlooking them. The Government is corrupt and they are using their land of *KREMA* for their own individual gains. They also alleged that the present government is intending to repeat the horrors of holocaust against them.

Hence, they have the right of self- determination. They formed their interim government in the land of *KREMA* and formed their own army to fight with the Urainian Authorities and armed forces. The army of the Tribal Groups kicked out the Urainian Armed Forces from *KREMA* and gained total control over the land of *KREMA*. The *URAINIE* Government accused *ROOS* for supplying arms to the protesting group. The Interim Government of *KREMA* after gaining total control of the land of *KREMA* held a referendum and people of *KREMA* who belonged to that tribal group decided to merge with *ROOS*.

13. The Temporary Government conveyed the results and gave the proposal to the President of *ROOS* who was that they wanted to be a part of their country for social security, peace and developmene. P Vutin accepted the proposal and made *KREMA* officially a part of *ROOS* by giving the reason that *ROOS* had always believed that all regions which were previously the part of URSS were one and this step by the interim government of *KREMA* is correcting the historical wrong which lead to disintegration of URSS. The Government of *URAINIE* went to the United Nations against this action of the Government of *ROOS*. United Nations along with URA condemned the acts done by *ROOS*. United Nation General Assembly through voting passed a resolution that they are and have not recognised in any form the interim government of *KREMA* and the referendum held by them is void and hence the annexation by *ROOS* in pursuant to this referendum is also void. But *ROOS* started claiming *KREMA* as an integral part of *ROOS* and also said that the people of *KREMA* had by their own will and due to indiscriminate behaviour of the Urainian Government had chosen to become a part of *ROOS*.
14. This dispute continued at international level between *URAINIE* and *ROOS*. URA gathered support in favour of *URAINIE* and against *ROOS* across the world. But *ROOS* was economically strong and because the whole world was economically dependent on it hence there were no bigger consequences which *ROOS* had to face.
15. In 2022, the Government of *URAINIE* declared their intention of become a member of JAN. The Urainian Prime Minister made a statement that the State of *ROOS* has not acted as per the International laws and principles. The arbitrary actions of *ROOS* in the form of annexation of *KREMA* are the major reason that they wanted security and the best option for their nation in that case was to join JAN. The President of URA and the heads of other member nation of JAN issued a public statement that they will be considering the option of including *URAINIE* in JAN. The moment *URAINIE* complies with all the necessary pre-essentials of becoming a member of JAN, the member nation will then officially include *URAINIE* in JAN and then all the benefits which the JAN member enjoys will then be available for *URAINIE* also.
16. The President of *ROOS* in reply to this development said that the State of *ROOS* is adamant to its vision of reclaiming the lost territories of URSS and hence with this vision *URAINIE* is always having the option of becoming the part of *ROOS*. The President further said that since we are neighbours we have shared cultures, economic interests and have a historical past hence *ROOS* is suited to be a natural ally of *URAINIE*.

17. But if the Urainian Government in connivance with URA wants to make an unnecessary and political move of becoming ally to JAN group and the whole JAN group led by URA have objective of coming to the borders of *ROOS* and carry out any of their mischievous operations then the State of *ROOS* will also act in self-defence and take necessary actions in the interest of their nation.
18. After this war of words, still the Prime Minister of *URAINNE* and the President of URA made public statements of *URAINNE* joining JAN. In February, 2023 a notification was uploaded on the official website of JAN that they will be holding an official meeting of its member nation on 23rd July, 2023. *ROOS* thought that in this meeting JAN would make *URAINNE* officially a part of JAN and the whole JAN Members headed by URA would stand on the borders of *ROOS* and use *URAINNE* as their puppet not only on the war front but also on the economic front.
19. *ROOS* under the leadership of his president P. Vutin decided to launch a military action against *URAINNE*. In pursuant to this decision the Air force of *ROOS* entered into the territory of *URAINNE* and launched strikes in various cities of *URAINNE*. The External Affairs Ministry of *ROOS* defended this action as an act in self-defence and to secure and protect the borders and interests of the people of *ROOS*. The statement also included that the government of *URAINNE* is acting arbitrarily against the minority groups in *URAINNE*. The present government of *URAINNE* is not legitimate as they were elected by fraudulent means and in connivance with the State of URA and is indirectly controlled by URA. Hence in order to secure peace in the state of *URAINNE* and to protect the interest of neglected minority groups *ROOS* launched such an operation. Also in the past *URAINNE* and URA have been acting in combination to disturb the peace and internal security of *ROOS*, hence the State of *ROOS* is left with no other option but to launch this military action.
20. The military action by *ROOS* led to the death of many soldiers and civilians of *URAINNE*. The State of *URAINNE* refuted such allegations and claimed that since they are a sovereign country, hence they are well within their rights to take their own decisions as to what group and what ally they want to choose. The allegations of *ROOS* that we have been involved in causing internal disturbance in *ROOS* are baseless and without any proof. The State of *URAINNE* requested the member countries of JAN to expedite their process of making *URAINNE* as a member nation. The JAN officially condemned the actions so taken by *ROOS* but they also issued a statement that they will consider the application of *URAINNE* for the purpose of joining JAN only when the situation normalises in that region. URA also condemned the actions of *ROOS* and pledged to stand by *URAINNE* in these difficult times. URA's parliament approved a military aid for *URAINNE*. *URAINNE* also strongly replied to the attacks by *ROOS* air force and army. Consequently, many of the soldiers of *ROOS* were also killed.

21. *URAINÉ* and *ROOS* both are members of the United Nation. *ROOS* is even the permanent member of the United Nation Security Council. Due to loss of innocent lives of common people, *URAINÉ* raised this matter before the United Nation General Assembly and sought relief on humanitarian grounds. The United Nations took notice of the matter on 01st July, 2023. The United Nations also condemned the actions of *ROOS*. At this date due to this military action by *ROOS* lakhs of people have been displaced and thousands of people have died. The United Nation Secretary- General filed a written request seeking an advisory opinion of the International Court of Justice (ICJ) on this matter. The ICJ has listed the matter on 20th of April, 2024 and has sought written submissions from *URAINÉ* (Petitioners) and *ROOS* (Respondents) for the same.

NOTE:

- ❖ The parties can frame any number of issues but have to strictly confine themselves to the corners of this moot proposition.
- ❖ The International Laws and conventions which apply to Russia and Ukraine will apply mutatis mutandis to *ROOS* and *URAINÉ* respectively.
- ❖ The parties can take help of any of the general principles of International Laws while making their case.

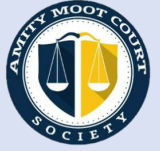
