FIRST NATIONAL LEVEL MOOT COURT COMPETITION, 2024 RULES AND REGULATION

DATE OF THE COMPETITION

11TH- 12TH MAY, 2024

LANGUAGE

The language of the competition shall be English only

ELIGIBILITY

Law Schools / Colleges / Institutes / Universities, recognized by the Bar Council of India are eligible to participate in the National Level Moot Court Competition, 2024. The participants should currently be pursuing their Bachelor's Degree in Law, i.e. Three Year or Five Year Law Courses.

COMPOSITION OF TEAMS

Each team shall have two mooters and one researcher.

STRUCTURE OF ROUNDS

The oral rounds shall comprise of :-

- a) Preliminary Rounds
- b) Researcher's test
- c) Quarter Final Rounds
- d) Semi Final Rounds
- e) Final Round

(A) PRELIMINARY ROUND

- There shall be two Preliminary Rounds. Each team will be given the opportunity to argue on both sides (i.e. Petitioner and Respondent) in the Preliminary Rounds which shall be determined by way of drawing of lots. Each team shall get a total of 25 minutes to present its case.
- This time will include five minutes of rebuttal. The
 division of time between the speakers is at the
 discretion of team members, subject to a maximum of
 15 minutes for any one speaker. Before the
 commencement of arguments, each team shall inform
 to the Court Clerk as to how it wishes to allocate its 25
 minutes.

 The top teams based on cumulative marks (written and oral submissions) shall qualify for the Quarter Final Rounds. In case of a tie, memorial score will be considered to break the tie. If the memorial marks are equal, then the speaker scores will be considered to break the tie. If the tie is not broken, then the team to advance to the Quarter final rounds will be decided by drawing of lots.

(B)RESEARCHER TEXT

- Researcher's test will be conducted on 25th November 2023.
- The participant, who is registered as the researcher, shall only be allowed to participate in the Researcher's test.
- The score of the researcher's test shall not be considered for the overall total score of the participants. It shall be considered only for selecting the Best Researcher.

(C) QUARTER ROUND

- In the Quarter Final round, each team shall argue for only one side, which shall be determined by drawing of lots. On the basis of knock-out, 4 (four) teams shall advance to the Semi Final rounds. The rules governing the preliminary rounds regarding time are applicable to Ouarter Final rounds.
- In case of tie, the speaker scores scored at the Quarter Final rounds will be considered to determine team qualifying for the Semi Final rounds. If still tie is not broken, then the team advancing to the Semi final rounds will be decided by drawing of lots.
- Each team shall get a total of 30 minutes to present its case.
- This time will include five minutes of rebuttal. The division
 of time between the speakers is at the discretion of team
 members, subject to a maximum of 20 minutes for any
 one speaker. Before the commencement of arguments,
 each team shall inform to the Court Clerk as to how it
 wishes to allocate its 30 minutes.





(D) SEMI FINAL ROUND

 IN SEMI FINAL ROUNDS The rules governing the Quarter Final rounds shall be mutatis mutandis applicable to the Semi Final rounds. On the basis of knock – out, two teams shall advance to the final round.

(E) FINAL ROUND

- In the final round also each team shall argue for only one side which shall be determined by way of drawing of lots. Each team shall get a total of 40 minutes to present its case. This time will include rebuttal. The division of time is at the discretion of the team members, subject to a maximum of 25 minutes for any one speaker (including rebuttal time).
- In case of tie, the rules governing Quarter Final and Semi Final rounds shall be mutatis mutandis applicable to final round.

WRITTEN SUBMISSION

- Each team shall submit 4 sets of written memorials (4 Petitioner's and 4 Respondent's memorials) & carry 4 sets of memorials with them.
- The Cover Pages of the memorials for the Petitioners shall be in blue and for the Respondents shall be in red.
- The identity of the institution/team shall not be revealed for any reason and in any form whatsoever, anywhere in the memorials. After the cover page next page should be the name of the college/institution which will be removed later after giving code.

- Memorials for the Petitioners shall be in blue and for the Respondents shall be in red.
- The identity of the institution/team shall not be revealed for any reason and in any form whatsoever, anywhere in the memorials. After the cover page next page should be the name of the college/institution which will be removed later after giving code.
- The soft copies shall be mailed on mvmmcc24@gmail.com only in MS Word 2003 (DOC) and PDF format on before 02/05/2024.
- The hard copies of the memorials shall be submitted on or before 06/05/2024 (4 Copies from both side),
- failure of which may result in cancellation of registration of the team. The hard copies of the memorial shall be printed from the DOC or PDF sent as soft copy. For evaluation of the memorial, either the hard copy or the soft copy may be used at the convenience of the organizers.
- . The written memorials shall conform to the set standards.
- Written submissions shall be printed on one side of white standard A4 size paper with margins of one inch (2.5 cms) on all sides except the left side where margin shall be of 1.5 inch (3.75 cms).
- The font and size of the text used in all parts of the written submissions (except the covers) shall be in 12 point Times New Roman and footnotes shall be in 10 point Times New Roman.
- The text in all parts of each written submission shall have
 1.5 lines spacing except the text of footnotes and headings which shall be single spaced.
- The comprehensive arguments with appropriate citations shall be contained in the Pleadings. The teams shall follow the 19th edition of the Bluebook mode of citation.

The Pleadings shall not exceed 20 pages.

DISPUTES

 Any dispute about the Moot Court Competition shall be referred to the Organizing Committee before commencement of next round of the competition. In all matters of complaints or disputes, the decision of the Organizing Committee shall be final

DRESS CODE

- Ladies: Black Trousers, White Shirt, Black Blazer and Black Formal Shoes.

ACCOMODATION

Outstation participants will be provided with accommodation for the duration of the competition. Only the registered three (3) members' team shall be provided accommodation.

 Any extra member shall make his/her own arrangements for the same. Girls and boys shall be allowed separate accommodation. They have to maintain strict discipline and desist from causing any annoyance, disturbance or any other inconvenience to other guests staying in the hoste. Any violation of this rule by any member of the team will lead to disqualification of the team and they will have to arrange for their own accommodation.

MISCELLANEOUS

Scouting shall lead to the instant disqualification of the team

- In case of an odd number of teams, the host institution shall constitute a team only for the Preliminary rounds so as to prevent ex-parte proceedings in any court.
- Moot problem being the property School of Law, MVM, shall not be used by any other college, institution etc, save with the written permission of School of Law, MVM.
- The organizers will not defray the TA/DA of the participating teams. However local hospitality will be provided to the participants.
- The organizers reserve the right to use the Memorials submitted to them after the competition as they deem appropriate.

- All participants shall maintain the decorum throughout the competition and are expected to conduct themselves in a manner befitting the legal profession, whether in the Court Hall or outside.
- Use of mobile phone in any form during the competition is strictly forbidden. Violating team may lose marks or may be disqualified in extreme circumstances.
- Consumption of any tobacco related product and any intoxicating product is strictly forbidden on the college campus.
- The organizers reserve the right to alter, modify, amend, add to or change any of the rules mentioned above and also date of competition at any time without any prior notice.

MOOT PROBLEM

- 1.Rohit Mehra is a 28-year-old entrepreneur. He completed his MBA in Marketing from the Indica Institute of Management (a prestigious institute) (Batch 2017–19) in Lekhnow, Uttam Pradesh, Indica. After completing his graduation, Mr. Rohit Mehra went abroad for a year to learn the art of perfumery in the renowned state of Francis (a country in Europa). After returning, he started his own company of perfumes with the name 'Scents'. The company has built a good reputation in the Indiana market in a very short span of time.
- 2.Preeti Singh, a 27-year-old marketing executive, completed her education at the Indica Institute of Technology (Batch 2017-19) in Lekhnow, Uttam Pradesh. After graduating, she got a campus placement from the college itself in a renowned company, 'TCM', where she has been working since then as a software developer at a good pay.
- 3.During their masters, both used to work on many projects during thier internship and field assignments and soon developed a strong sense of liking for each other. Preeti was mesmerized by Rohit's charm and ambition, whereas Rohit was awestruck by preeti's beauty and intelligence. They both confessed their love to each other on 10th March 2018.
- 4. Their love was intact even when Rohit went abroad to study the art of perfumery in 2019. The two used to have long conversations over voice calls, instant messages and video calls for over a year. After returning to Indica, their relationship became stronger than ever both physically and emotionally.
- 5.While in relationship Rohit used to take Preeti with him to all the social gatherings and functions. On the night of November 20, 2022, Rohit took Preeti to his brother's marriage, where she met Rohit's family and relatives. Rohit introduced Preeti to his mother, where Rohit's mother, after meeting preeti ,asked both of them, "When will you two throw a similar function for us?". Listening to the question, Rohit and Preeti looked at each other and smiled, and then Preeti said, "Soon." Listening to the same Rohit, he did not respond.
- 6.Also, Rohit used to introduce Preeti to his friend circle, thereby bringing their relationship into the knowledge of their social circle. Rohit, during a party when he was in a drunken state, was asked by his friends Aditya and megha, who were married, about the future of his relationship with preeti, to which Rohit replied, 'Preeti will make a perfect wife'. The same conversation was narrated to Preeti by megha without the consent or knowledge of Rohit. Rohit was unaware of any such communication being made to preeti by Megha.
- 7.Rohit and Preeti started living together. Rohit pitched an idea to Preeti that she should work with him and develop an app for his perfume company 'Scents' so that they can sell their perfumes directly without involving other shopping applications like Amacon, Flipmart etc. Riya liked the idea and started working on developing the app for it, but at the same time, iterated that she would not quit her job.
- 8.As they were in a relationship, no formal written contract was executed between the two, and thus the entire agreement was based on the exchange of messages on ChatsApp (an instant messaging application).

- 9. Over a ChatsApp chat on 13th May 2023, both of them agreed on a payment structure in which Preeti will get a lumpsum amount of Rs.10 Lac once the application is developed. However, the mode and timing of payments were not clearly defined.
- 10.As the work progressed, the parties experienced disagreements relating to the development of the application, with Rohit claiming that some crucial aspects of the project were left as Preeti was not able to balance her job and working on the application at the same time, thereby leaving Rohit frustrated.
- 11.As a consequence of the same, Rohit denied adequate payment as promised in the WhatApp chats on the ground of a deficiency in services rendered, thus annoying preeti .But Rohan calmed her down so that their relationship was not affected.
- 12.On November 17, 2023, Preeti asked Rohan to marry her, which Rohit denied and thereby called off the relationship.
- 13. Meanwhile, feeling deceived and emotionally distressed, filed an FIR alleging that Rohit had engaged in sexual intercourse with her on the pretext of marriage, and now he was refusing to fulfil his promise. Rohit denies any expressed promise relating to marriage made by him, whereas Preeti contends that an implied promise of marriage was made and thus she gave her consent for sexual intercourse on the pretext of marriage.
- 14. Following the same, medical tests were performed and it was confirmed on the basis of reports that sexual intercourse took place frequently between Rohan and Riya. However, nothing was concluded on the matter of consent.
- 15.As a consequence of the same, Rohit twas arrested. Rohit was presented before the magistrate.
- 16.Rohit was denied bail and was later acquitted for the charges by Trial Court of Lekhnow. The trial court held that, both Preeti and Rohit were in consensual relationship, therefore, Rohan cannot be held liable for Rape.
- 17.Preeti filed an appeal against the trial Court's Order in High Court of Ultra Pradesh. The High Court reversed trial Court's judgment and convicted Rohit for the charge of Rape on the pretext of Marriage. Rohan then filed a Special Leave Petition in Supreme Court of Indica against High Court's order.
- 18. Rohit further asked the court to take into consideration that his family had been looking out for a bride on marriage platform Jeevanteresaathi.com and thus, he and Rohit (the girl who agreed to marry him through Jeevanteresaathi.com) have decided to get married and that his fundamental Right to Marry enshrined by the Constitution of Indica would be violated.
- 19. However, Preeti also filed a suit for breach of contract. To which Rohit alleges that conversations on ChatsApp are not formalin nature. He also contends that WhatApp chats does not form a valid contract.
- 20.Apart from this, Rohit has also challenged the constitutional validity of Section 375 of the Indica Penal Code, 1860, entitling only women to file a case on the ground of consent on the pretext of marriage and





the same not available to men.

21. The Hon'ble Supreme Court of Indica, for the sake of convenience, decided to hear all the cases on the same day with the following issues:

<u>ISSUES</u>

•	Whether the Special Leave Petition is Maintainable in the Hon'ble Supreme Court of Indica.
•	Whether the agreement entered into by Rohit and Preeti on ChatsApp amounts to a valid contract recognizable by laws in Indica?
•	Whether the consent for sexual intercourse was given by Preeti only the pretext of marriage and does it amount to rape under Section 375 of Indiana Penal Code.
	Whether a denial of bail for Rohit for the purpose of his marriage would amount to an infringement of his fundamental right under the Constitution of Indica?

NOTE:

- 1. The laws in the Union of Indica and the Union of India are in pari materia.
- 2. The Counsels representing both sides are required to address the issues that are specifically mentioned in the moot problem.
- 3. The Counsels may formulate their own sub-issues in the above-mentioned issues.




