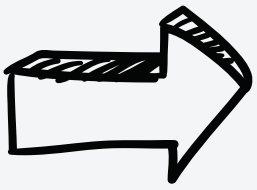

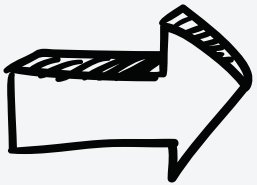


# About The University

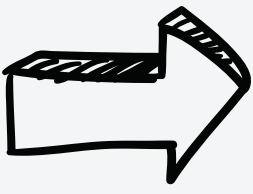


# **About National Moot Court Competition, 2024**

The competition strives to give a platform to the budding lawyers of our country to imbibe analytical skills in real-time situations. The aim is to engage with students and allow them to have the first-hand experience of the complexities of the law



# Moot Proposition

Ruhi, a girl around 16 years of age, belonging to poor labourer family, lives in city named Manpura, situated in the Republic of Industan. Ruhi used to get training of sewing of clothes at a Silai centre registered under Pradhan Mantri Kaushal Vikas Yojna. She had to dropped out from school during her 7th class due to family financial conditions.

On February 12, 2024, when she was going to training centre, a boy named Manav, called her and told that her friend Jiya is calling her. Manav was working in a shopping mall nearby training centre. The boy on this pretext took her to Hotel Aavhan on his bike. She went to the room at first floor of the hotel along with him. Manav offered her forcibly two intoxicating tablets along with cold drink. After five minutes, she started feeling dizzy and was not conscious. Then he committed rape upon her. When she regained consciousness, there was no clothes on her body. He also prepared her obscene video and clicked her nude photos. He gave her a pill and threatened that if she will disclose about the incident and video to anybody, he will kill her parents. After that, he left her back to training centre. He also gave her a mobile phone and told her that if she will not talk to him through this phone, then he will kill her and her parents.

Later on, he started threatening her and demanding her nude videos, and if she will not send the same, he will kill her family members. He used to ask her to send her videos with smiling face. For this, Manav created Ruhi's account on Instagram, through which she used to send her obscene videos & photos to Manav. Hence, he was blackmailing her and she was badly scared and started living upset. Ultimately, she informed her parents about the whole incident.

On the basis of this complaint, FIR under Sections 363, 366-A, 328, 506 of Industan Penal Code, 1860, Section 4 of the Protection of Children from Sexual Offences Act, 2012; and Sections 67, 67-A of the Information Technology Act, 2000 was registered against Manav.

The counselling of Ruhi was got conduced from Child Welfare Committee, Manpura. Her medical-examination was conducted and her samples were sent to the Laboratory.

During investigation, the rough site plan of place of occurrence was prepared. The statement of Ruhi, under Section 164 of Cr.P.C. was got recorded. The copy of her birth certificate was not found with authorities as her family is a migrant labour. In absence of birth certificate of Ruhi, ossification test was conducted, wherein her age was opined around 16 years and almost the same was found in her school record from where she dropped out in 7th standard.

he mobile phone which was given by Manav to Ruhi was taken into the police's possession. The accused was arrested by police and his mobile phone was also taken into police possession. His medical examination was conducted and samples were sent to Laboratory.

After completion of necessary investigation proceedings and usual formalities, challan under Section 173 of Cr.P.C. was presented in the Court for trial of the accused, Manav. It was also found that her parents were not aware of Ruhi's friend Jiya. The Father i.e., Complainant, failed to give reasonable cause about delay in filing of complaint. The investigating officer when inquired about record of hotel bookings, the Receptionist has deposed that the guest register of their hotel was destroyed by termite. Ruhi's Mother denied the suggestion that accused is not known to her daughter/ victim or that she never met him at any point of time.

The Medical Officer conducted medico-legal examination of Ruhi and opined that the possibility of sexual assault cannot be ruled out. She stated that nowadays, the female child derives the age of puberty at the age of 13. There is possibility of rupture of hymen due to cycling, horse riding, gymnastics, and any other such like physical activity. Sexual assault may be one of the reasons for the same but it cannot be the sole cause.

The photographs which are on record have been relied upon by the prosecution to prove that the accused enticed the victim-prosecutrix in a room of the hotel and committed sexual acts with her. The Prosecution contended that the photographs showing both boy and girl were obscene and thus, the accused has committed penetrative sexual assault upon the minor victim-prosecutrix.

On the other hand, the Learned Defence Counsel stated that no doubt, the photographs in CD & DVD have been proved on record but original media is not available on record and mere testimony of the victim prosecutrix does not inspire confidence to prove the case of prosecution. In her cross-examination, she has admitted that she knew the accused for the last one month.

The trial court held the accused guilty for the commission of offence punishable under Section 67-B of IT Act. Further concluded that the prosecution has failed to prove its case against the accused under Section 328, 363, 366-A, 506 of IPC and Section 4 of the POCSO Act, 2012 and therefore, he is acquitted under these Sections, whereas the prosecution has been able to bring home the guilt against the accused and he was held guilty for commission of offences punishable under Section 67-B of IT Act and convicted therein.

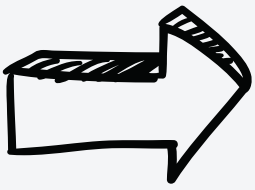
The appeal was filed in High Court against the judgment of trial court. The High Court affirmed the decision of trial court. Now, the appeal is filed against High Court's decision in Hon'ble Apex Court of Republic of Industan.

The Constitution of Republic of Industan and other laws are in pari materia with the Constitution of India and its Statutes.

# **RULE BOOK**

## **1. RULES AND REGULATIONS**

The Organising Committee of the National Moot Court Competition will have exclusive authority to interpret the rules in the interest of just and fair competition. The definitions placed below by the Organising Committee shall be final and the decision of the Organising Committee regarding the applicability of these rules will be final.

## **2. DEFINITIONS**

- ‘Bench’ refers to the members duly invited by the institute, to adjudge any of the rounds, collectively.
- ‘Clarifications’ means any questions, queries, or doubts sent by the registered teams to the organisers, within the given deadline.
- ‘Competition’ means the 1st National Moot Court Competition, 2024.
- ‘Speaker’ refers to a participant who presents oral arguments in any given round.
- ‘Penalty’ refers to the deductions imposed on the memorandum scores of a participating institution.
- ‘Participating Team’ means the team which has registered itself for the competition as per the rules for registration.
- ‘Participating Institution’ shall be presumed to be the institution of the participating teams.
- ‘Moot Problem’ means a set of facts published by the institution for moot court competition.
- ‘Rebuttals’ refer to those arguments/ questions that the Complainant may raise at the end of the main pleadings of all the Orators.
- ‘Sur-rebuttal’ refers to the defense presented by the Respondent to the rebuttals.
- ‘Organiser’ means School of Legal Studies, Sangam University.
- ‘Organising Committee’ means the Moot Court Committee (MCC).
- ‘Scouting’ means a person observing the Oral Rounds of a team other than the team such person is associated with.
- ‘Team Code’ refers to the code allocated to a participating institution by the organising committee after completion of the Registration.

### **4. LANGUAGE**

The official language of the competition shall be English only

### **5. TEAM COMPOSITION**

The team shall comprise of either two members (being designated as Speakers and one of the speakers shall be designated as Researcher) OR three members (two of them shall be designated as Speakers and one of them shall be designated as Researcher). No team will be allowed to substitute any of its members after a team has submitted its Registration form, except with the permission of the organisers.

## **6. DRESS CODE**

The participating teams must adhere to the following dress code during the Moot Court Competition -

Male - White shirt, black trousers, black tie, black coat, and black shoes.

Female - White salwar and kurta or white shirt and black trousers along with a black coat and black shoes.

## **7. REGISTRATION PROCEDURE**

- Online registrations are open from March 30, 2024.
- The teams must register online by April 14, 2024.
- The registration shall be done by filling up the registration form [Available Here](#).
- The registration shall be considered complete only when the 'Registration Fee' has been paid successfully and the registration form is duly filled with all the credentials.
- The participants will receive an official approval mail from organising committee carrying the 'Team Code' latest by April 18, 2024 or earlier.
- The teams shall quote their respective team code in all further communications with the organising committee.
- The registration fee for the competition is INR 1700/- (with Accomodation or INR 1500/- (without Accomodation).
- Registration fee once paid is non-refundable.

## **8. CORRECTION AND CLARIFICATIONS**

The team(s) may request for correction and clarification regarding the moot proposition as per the date given in the important dates, i.e., April 20, 2024. Such requests shall be sent at nmccsangamuniversity@gmail.com only. No other mode of communication will be taken into consideration.

## **9. MEMORIAL SUBMISSION**

- All memorials submitted for all purposes of the Competition shall firmly comply with the rules of the competition.
- Each participating team must prepare two written submissions, one for each Petitioner/ Applicant(s) as well as Respondent(s) side.
- Petitioner/ Applicant(s) memorials are required to have a [Blue](#) cover and Respondent(s) memorials are required to have [Red](#) cover.
- Only soft copies of memorials shall be submitted in both .pdf and .doc/.docx format latest by 11:59:59 PM on April 18, 2024 through at nmccsangamuniversity@gmail.com only.
- Late submissions shall be penalised (1 mark per day) and no memorial shall be accepted after two days from the specified date.

## **10. MEMORIAL CONTENT**

The memorial must contain the following pages only: -

- **Cover Page** – The cover page shall contain the Case Title, Side of the Memorial, Year of the Competition, Name of the Court, and Team Code on the top right corner.
- **Table of Contents**
- **Index of Authorities**
- **Statement of Jurisdiction**
- **Statement of Facts**
- **Issues Raised**
- **Summary of Arguments**
- **Arguments Advanced (20 Page max.)**
- **Prayer**

## **11. GUIDELINES FOR MEMORIAL FORMATTING**

The following content specifications must be strictly followed: -

- The memorial shall be typed on an A4 size page and all the pages of the memorial should have a page number at the bottom.
- **Font and Size (General)** – Times New Roman, 12 pts.
- **Line Spacing (General)** – 1.5 lines.
- **Font and Size (Footnotes)** – Times New Roman, 10 pts.
- **Line Spacing (Footnotes)** – Single lines.
- All the citations and footnotes must be in compliance with the 20th Edition of Bluebook.

## **12. PLAGIARISM**

The written submissions in the memorials will not be plagiarized. A similarity index of more than 20% considering the standard exclusions, is not acceptable.

## **13. ANONYMITY OF TEAMS**

- Teams shall not reveal their identity in any form, except by means of the Team Code allotted to them during the Competition.
- The Written Submissions shall not reveal the identity of the team in any form and should not bear the logo, name, etc. of the University represented.
- Any violation of the above rules shall attract severe penalty or disqualification as determined by the organising committee.
- The decision of the organising committee in this regard shall be final and binding on the participating team.

#### 15. EXCHANGE OF MEMORIALS

- The Exchange of Memorial for the Preliminary Round will be on April 23, 2024.
- The memorial exchange for the advanced rounds of the Competition shall take place prior to the commencement of the advanced rounds (Quarter-Finals, SemiFinals, and Finals) wherein hardcopies of the respective memorials shall be provided.
- Teams are prohibited from making any remarks on the opponent's Memorial, i.e. the exchanged memorial. Teams are also prohibited from making any copies of the opponent's Memorial, electronically or otherwise.

#### 16. RESEARCHER'S TEST

- The Researcher's Test for the Competition will be conducted on April 23, 2024.
- The Researcher's test will be conducted in offline mode and venue for the test shall be the same as the venue of the competition.
- It shall be a test of 100 marks and it is mandatory for the Researcher of each participating team to give the Researcher's Test.
- If any team fails to appear for the researcher's test, they shall be awarded with zero marks.

#### 17. STRUCTURE OF ORAL SUBMISSIONS

- The Competition shall consist of Preliminary Round; and Advanced Rounds including the Quarter-Finals; Semi-Finals; and the Final Round.
- During each of the above-mentioned rounds, the order in which the teams shall present their arguments is as follows:
  - Appellant Speaker 1 & Appellant Speaker 2;
  - Respondent Speaker 1 & Respondent Speaker 2;
  - Rebuttal: Appellant - Any one of the two Speakers; and
  - Sur-rebuttal: Respondent - Any one of the two Speakers.

#### 18. TIME DIVISION BETWEEN SPEAKERS

- Each Teams shall be furnished with 15 mins. for their Oral Submission (inclusive of division of time between the 2 Speakers).
- Teams exceeding the time limit for the oral rounds shall be awarded with a deduction of 2 (two) marks for every minute.

- The Organizers shall arrange Breakfast, Lunch, and Dinner only for above 2 days of the competition all the participants, as applicable.

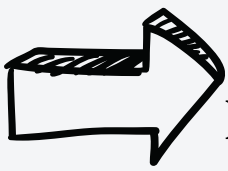
## 21. MISCELLANEOUS RULES
