It is a response to the needs of disadvantaged groups being processed by the Criminal Justice System. It aims at socio-legal and economic rehabilitation of persons who are at risk of being criminalized, exploited for commercial sex, and those in destitute states.

Prayas invites interested candidates to apply for the post of Legal Fellow (Male Candidate & female Candidate) (on contract for Seven Months).

Post: Legal Fellow (Male & Female Candidate) (on contract)

Location: Mumbai and Thane

- During contract period, Fellow shall not take up any other employment without the prior permission of the employer.
