SAKSHAM 1.0 & SAKSHAM 2.0

Project Saksham 1.0 was an initiative by the Nek Mission Foundation from September 2022 to December 2022. It was in collaboration with the Central District Legal Services Authority and many other agencies. The project focused on 05 specific areas, with 10 teams assigned to conduct 50 Ground visits covering 6248 houses. The project successfully touched and made a difference in the lives of 28,745 people.

Project Saksham 2.0 was a collaborative initiative involving Law Centre 1, Law Centre 2 of the Faculty of Law, University of Delhi, Indraprastha University, Jamia Hamdard University, Nek Mission Foundation and Naksh Foundation from **2 May 2023 to 5 December 2023**.

PHASE 01 :

Field visits and Survey

They involve -

- Comprehensive data collection
- Survey regarding documentation
- Inquiry about potential legal issues such as domestic violence or exploitation
- Awareness about government support and legal helpline number to avail free legal support.

Mega camps:

Based on the data collected, the team set up the following mega camps under the supervision of prominent advocates and health specialists:

- Legal awareness camps
- Health camps
- Document aid desks

PHASE 02 :



Seminars, Workshops, Moot court Competitions, National Conference etc.

By organizing such activities, the project aims to provide a platform for learning, connecting with experts, fostering collaboration, and encouraging innovation, ultimately contributing to personal, professional, and societal growth.



Training sessions on POCSO & Cyber Laws in schools

- Training sessions on the POCSO Act aim to educate participants about the provisions of the act, raise awareness about child sexual abuse, and empower them to recognize, prevent, and report such offences.
- Training on cyber laws aims to increase awareness about online safety, prevent cyberbullying and cybercrimes, ensuring a safe and secure digital world.



Educational drives

With a focus on inclusivity and accessibility, the educational drives will provide a nurturing space for underprivileged youngsters and older adults to access quality education. The drives will include interactive lessons, skill-building activities, and mentorship programs, that aim to bridge educational gaps and empower children for a brighter future.

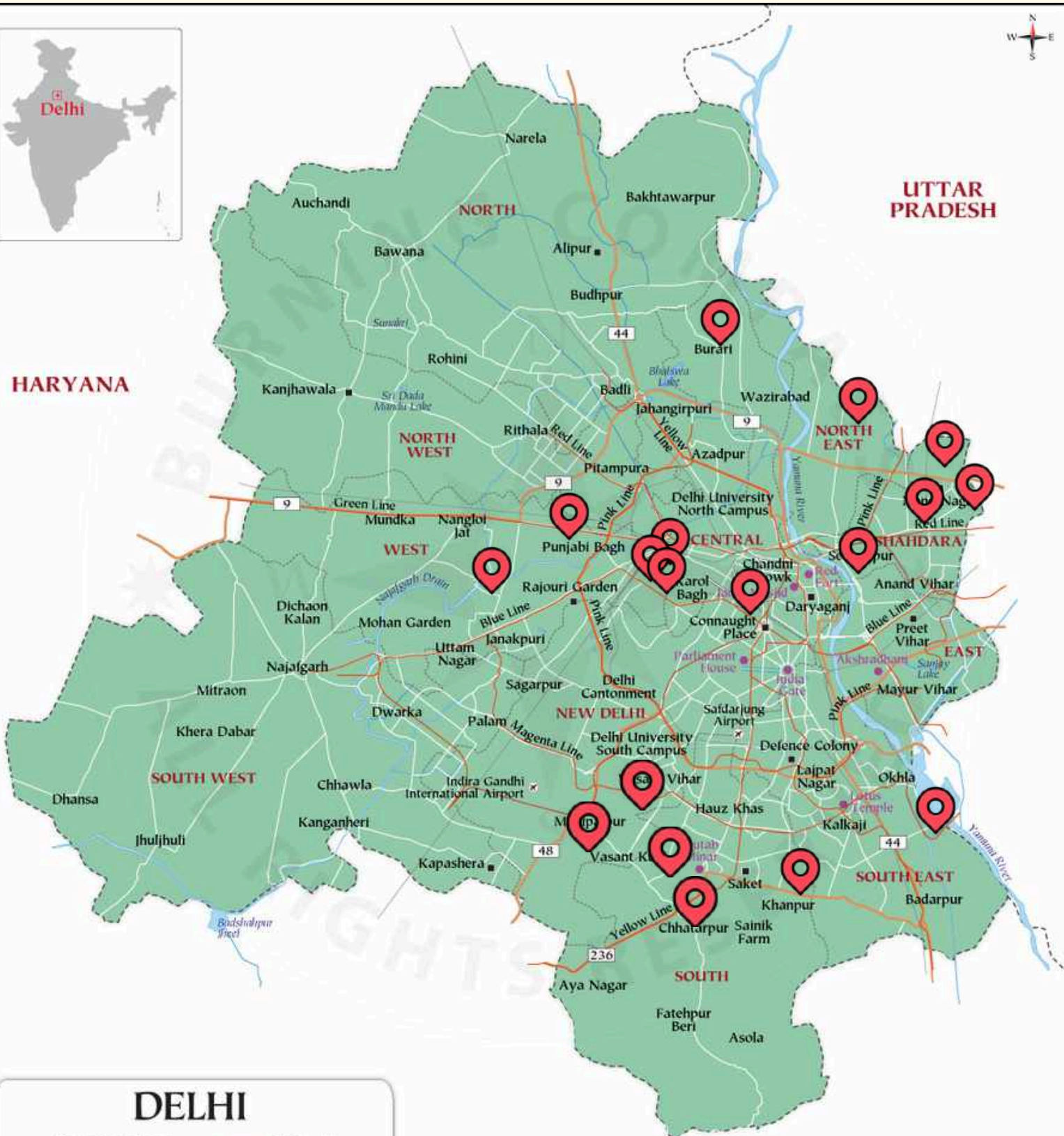

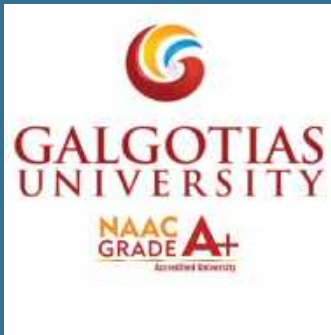
