## <u>About Department of Law,</u> <u>University of Calcutta:</u>

The Department of Law, University of Calcutta, Kolkata, West Bengal, formerly University College of Law, is a faculty in the University of Calcutta, founded in 1909, colloquially referred to as Hazra Law College, which offers undergraduate, postgraduate, doctorate and post doctorate courses. The college was established by the then Vice Chancellor of University of Calcutta Ashutosh Mukherjee in 1909. Prior to 1983, the Department of Law was known as the University College of Law. Sir Asutosh wanted it to be a model centre of legal education. In a meeting held on 4 July 1908, the Senate recommended the proposal to establish University Law College in Kolkata. Sir Surendranath Banerjee was also present at the meeting, which was presided by Andrew Henderson Leith Fraser, the Rector of the University. The resolution was passed that a college is to be established for the promotion of legal education of the students of Bengal for degrees in law and to serve as a model college. Finally the University Law College, started functioning under the management of a government body consisting of 16 members with the Vice-Chancellor as President from July, 1909. Eminent scholar and jurist Dr. S.C. Bagchi, became the first principal and Birajmohan Majumdar was appointed the first vice-principal of this College. The institution has produced some of the most renowned and reputed citizens including Chief Justices of the Supreme Court, writers, leaders of movements, politicians, along with the first President of India, Dr. Rajendra Prasad.

## **Blog Submission Guidelines:**

- 1. All works must be **original and unpublished**.
- 2. There are **no fees** for submission or publication.
- 4. Co-authorship is allowed to a maximum of **two authors**.
- 5. All written submissions should be in the form of a Word document (.doc or .docx format) or pdf.
- 6. The language of the submission: **Bengali**, **English** and **Hindi**

#### 7. Word limit:

**1000 words** for articles, prose, short stories, etc. **1 page shall be preferable** for poetry but must **NOT** exceed 2 pages.

- 8. Sexually explicit, overtly political, and plagiarised submissions will be rejected.
- 9. The writings **must not exceed 15% plagiarism.** Please make sure to **attach the plagiarism report** when you submit your work.
- 10. The submissions will be received from **July 7, 2024.**
