DETAILS OF THE ADVERTISEMENT

- 1. The job description of the Research Assists requires the ability to conduct preliminary research (both doctrinal and non-doctrinal) and data presentation and compilation. Proficiency in computer handling MS Word, Excel, Power Point, and Knowledge of basic statistical tools (with Excel/SPSS) is expected. Proficiency in English and Tamil is mandatory.
- 2. The selected candidates will also be required to work for organising seminar/webinar/workshops/conference for the respective Research Centre.
- 3. The Vacancy mentioned shall be filled up purely on temporary basis.
- 4. Eligible candidates are required to download and fill the details in the prescribed application form. A nominal application fee of Rs.100/- is to be paid in the account details given below. A candidate can apply for only one Research Assistant post for a given Research Centre. In case of multiple applications to the various Research Centres the candidates are required to fill the application forms separately, and also pay the required fee respectively.
- 5. The relevant supporting documents including qualifying degree/certificate/marksheets/PwD Certificate/ Community certificate/ proof of payment are to be enclosed along with the filled in application form.
