1. This is a Rolling Advertisement. There is no last date. Applications will be accepted throughout the year. Applications will be processed periodically. Some positions with sufficient suitable number of applications received by **September 12, 2024 upto 11:59 p.m.** will be processed for interview in the first phase. Applications received for other positions shall be considered for the next phase of interview for which the deadline will be notified on the university website in due course of time.
2. After successfully applying online through the link available in the university website, the self-attested copies of all the required documents along with application form should reach the university within 10 days from the notified last date for each phase by the university.
3. An application fee of Rs. 1,000/- (Rs.750/- for SC/ST/OBC/EWS/PWD) shall be paid online at the time of submission of Application form. Application fee is not refundable. Applications received without application fee will stand rejected.
4. Candidates applying for more than one post should apply in separate application for each post along with the fee prescribed.

6. **Minimum Qualifications for various positions at Department of Law and Department of Social Sciences & Humanities at NALSAR**

**I. Assistant Professor:**

**Eligibility (A or B) :**

**A.**

i) A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign university.

ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET :

*Provided*, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions:-

- a) The Ph.D. degree of the candidate has been awarded in a regular mode;
- b) The Ph.D. thesis has been evaluated by at least two external examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal;
- e) The candidate has presented at least two papers based on his/her Ph.D work in Conferences /seminars sponsored/funded/supported by the UGC / ICSSR/ CSIR or any similar agency.

*The fulfilment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.*

Note: NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SLET/SET.

**OR**

**B.** The Ph.D degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following: (i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

## **II. Associate Professor:**

### **Eligibility:**

- i) A good academic record, with a Ph.D. Degree in the concerned/allied/relevant disciplines.
- ii) A Master's Degree with at least 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed).
- iii) A minimum of eight years of experience of teaching and / or research in an academic/research position equivalent to that of Assistant Professor in a University, College or Accredited Research Institution/industry with a minimum of seven publications as research papers in peer reviewed reputed journals or journals ranked by SCImago / Scopus / Web of Science / listed by UGC / Other reputed journals\*\* (OR) Book chapters / Books published by reputed National / International publishers and a total research score of Seventy five (75) as per the criteria given in Appendix II, Table 2.

## **III. Professor:**

### **Eligibility (A or B) :**

#### **A.**

- i) An eminent scholar having a Ph.D. degree in the concerned/allied/relevant discipline, and published work of high quality, actively engaged in research with evidence of published work with, a minimum of ten publications as research papers in peer reviewed reputed journals or journals ranked by SCImago / Scopus / Web of Science / listed by UGC / Other reputed journals\*\* (OR) Book chapters / Books published by reputed National / International publishers and a total research score of 120 as per the criteria given in Appendix II, Table 2.
- ii) A minimum of ten years of teaching experience in university/college as Assistant Professor/Associate Professor/Professor, and / or research experience at equivalent level at the University/National Level Institutions with evidence of having successfully guided doctoral candidates.

**OR**

**B.** An outstanding professional, having a Ph.D. degree in the relevant/allied/applied disciplines, from any academic institutions (not included in A above) / industry, who has made significant contribution to the knowledge in the concerned/allied/relevant discipline, supported by documentary evidence provided he/she has ten years' experience.

## **GENERAL INFORMATION:**

1. The prescribed qualifications and experience are minimum and the mere fact that a candidate possesses the same will not entitle him / her for being called for interview. The University reserves the right to restrict the candidates to be called for interview to a reasonable number on the basis of qualifications and experience higher than the minimum prescribed; or by any other condition that it may deem fit. Those who are possessing higher qualifications will be given preference in short-listing the candidates. The University may constitute a Screening Committee to scrutinize the applications and short-list the candidates. Call letters for test / interview will be sent only to the short-listed candidates and no correspondence will be entertained with applicants who are not short-listed.
2. The candidates are advised to clearly identify their subject specialization as the University will keep the specialisations in mind while shortlisting the candidates as per its requirements.
3. It would be open to the University to consider the names of suitable persons who may not have applied, but recommended by the experts in their respective fields and by the Selection Committee.
4. The University will have the right to relax any of the qualifications, experience etc.
5. The University may offer a lower post to a candidate who may have applied for a higher post depending on his/her performance in the Selection Committee for the advertised posts.
6. Canvassing in any form on behalf of any candidate will disqualify such a candidate.
7. The Selection Committee may decide its own method of evaluating the performance of the candidates in interview. The University may conduct written test / skill test or seminar / colloquium / mock class as method of selection and there will be shortlisting after every stage.
8. Applications incomplete in any respect shall not be considered at all.
9. No interim queries regarding test / interview / selection will be entertained.
10. The University reserves the right to fill all the positions advertised or fill only some of the positions or not to fill any of the positions.
11. The University may offer contractual positions in place of regular positions either on UGC Pay Scales or on consolidated salary.
12. University will make all correspondence only through email.
13. In case of any disputes / suits or legal proceedings against the University, the Jurisdiction shall be restricted to the Courts in Hyderabad, which is the Headquarters of the University.
