The top four teams from the preliminary rounds will advance to the semi-finals, followed by a grand finale between the best two teams. **LAW TREK 2025** promises not only an intellectually stimulating experience but also a valuable opportunity for legal networking, critical thinking, and professional development on a national platform.

# RULES & GUIDELINES

## 1. TEAM COMPOSITION

- Only students from undergraduate Law colleges/Institutions recognized by the **Bar Council of India** are eligible to participate in the **CPJIMT Moot Court Competition 2025**.
- Each eligible College/Institution may nominate **One Team** consisting of **three undergraduate Law Students**.
- Each team must comprise of **two Speakers** and **one Researcher**.

## 2. DRESS CODE

- All participants are required to adhere to a formal **Dress Code** during the competition.
- **Male Participants** must wear a **black Suit, White Shirt & Black Tie**.
- **Female participants** may wear either:
  - A **White Shirt, Black Trousers** and a **Black Jacket** or **White Salwar Kameez** paired with a **Black Jacket**.
- **Gowns and Advocate Bands** are **strictly not permitted** during the competition.

## 3. MEMORIALS

- Each team is required to prepare **written Memorials** and **oral Arguments** for **both the Petitioner and the Respondent** sides of the case.
- The Court will follow procedures in line with standard **Judicial practice**. In case of any **dispute or ambiguity** relating to facts or procedure, the **decision of the Presiding Judge** of each bench shall be **final and binding**.
- A **soft copy** of the memorials for both the Petitioner and Respondent must be sent to the Convener at **Moot.cpjimt@gmail.com** on or before **20th September, 2025**.
- In addition, **5 set of hard copies** of each Memorial (Petitioner and Respondent) must be submitted on or before **1st Oct, 2025**.
- The memorials will be assessed by a **Panel of Judges** for evaluation and awarding of marks out of 100.
- Memorials **must not contain any identifying information** (such as names, logos, or college details) that could reveal the identity of the participating team. **Violation of anonymity** will attract **penalty marks**.
- The judges judgement shall be final and abiding for one and all



## 4. MEMORIAL CONTENT & FORMATTING GUIDELINES

- Each team must prepare **two separate memorials** - one for the **Petitioner** and one for the **Respondent**.
  - The memorial must comprehensively cover:
    - **Jurisdiction**
    - **Issues Involved**
    - **Summary of Arguments**
    - **Arguments with Legal Authorities**
    - **Conclusion & Prayer**
    - **Argument in Advance**
  - The **main body** of each memorial must not exceed 30 typed pages
- This 30-page limit includes:
- Pleadings
  - Conclusions

**Note:** The following sections are **excluded** from the 30-page limit:

- Cover Page
- Table of Contents
- Index of Authorities
- Jurisdiction
- Statement of Facts
- Questions Presented
- Summary of Pleadings
- Title Page and Back Cover
- **Important:** Any issue or argument not discussed in the body of the **Memorial** must not be included in any other section.

## 5. FORMATTING GUIDELINES:

- **Language:** English
- **Font (General Text):** Times New Roman, 12 pt
- **Line Spacing (General):** 1.5 lines
- **Font (Footnotes):** Times New Roman, 10 pt
- **Line Spacing (Footnotes):** Single line
- **Page Margins:** 1 inch on all sides

### Cover Page Specifications:

- **Petitioner's Memorial:** Blue Cover
- **Respondent's Memorial:** Red Cover





## 6. ORAL ROUNDS

### a. Matchups & Side Allocation

- Matchups and side (Petitioner/Respondent) for each round will be determined through **draw of Lots** during the briefing session
- The Moot Court Society may alter sides or matchups in exceptional circumstances such as team withdrawals or fairness considerations

### b. Time Structure

- Each round shall not exceed **one hour** in duration
- Each team is allotted **30 minutes**, inclusive of **rebuttal/surrebuttal**
- Each speaker must argue for **at least 10 minutes**
- Teams may reserve up to **5 minutes** for rebuttal/surrebuttal, which must be communicated to the Court Officer beforehand

### c. Rebuttal / Surrebuttal Rules

- If a speaker exceeds their allocated time, the excess will be deducted from the co-speaker or from rebuttal/surrebuttal time
- Judges hold the **final discretion** regarding time structure and permission to rebut/surrebut

### d. Language

- The **medium of oral submissions shall be English**

### e. Electronic Devices

- The use of **electronic devices** (laptops, phones, tablets) during oral rounds is strictly **prohibited**

## 7. EVALUATION CRITERIA

**Marks in the competition will be allocated as follows:**

### A. Memorials – 100 Marks

- Assessed out of a maximum of 100 marks by a panel of judges.
- Criteria include content, legal reasoning, formatting and adherence to rules

### B. Researcher Test – 100 Marks

- The test will evaluate legal research, comprehension and application skills
- Only teams with three members are eligible

### C. Oral Rounds

- **Preliminary Round – 100 Marks**
- **Semi-Final Round – 100 Marks**
- **Final Round – 100 Marks**

**Breakdown of 100 marks (for each Oral Round):**

- **Content & Legal Analysis – 20 Marks**
- **Mooter 1 Performance – 40 Marks**
- **Mooter 2 Performance – 40 Marks**

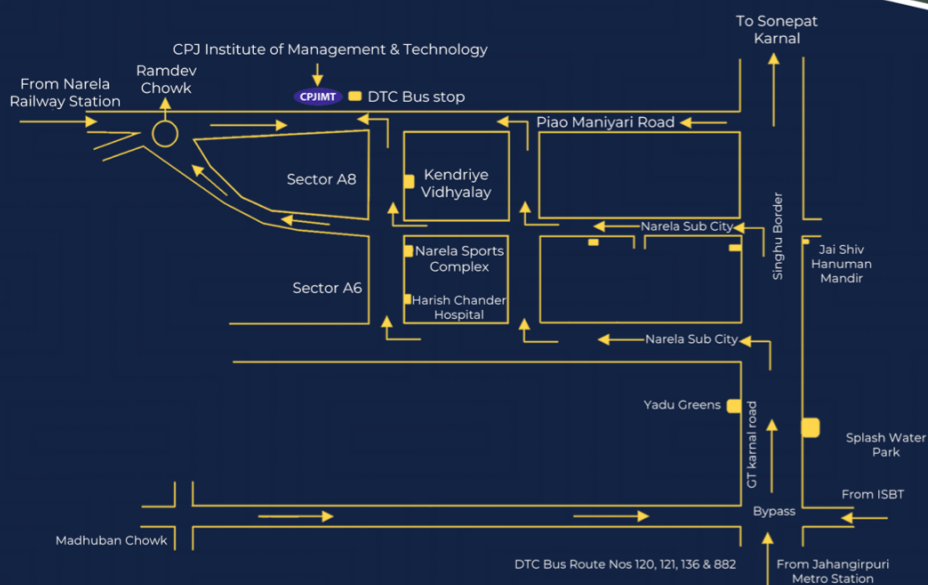
