About Lex Bonanza

About Lex Bonanza

Indore Institute of Law takes great pride in having hosted India's first-ever National Law Fest, Lex Bonanza, in 2012, which has since gained wide recognition among academicians, students, and legal enthusiasts. The event has served as a valuable platform for students to demonstrate their legal abilities and enhance their overall growth, firmly positioning the institute as a leading name in the global legal community.

Over the years, Lex Bonanza has grown into a prestigious legacy, expanding in scale, diversity, and reputation. The sixth edition in 2017 marked a significant turning point as it went international, welcoming teams from reputed institutions like the University of Nottingham (UK) and Eastern University (Bangladesh). The seventh chapter in 2018 witnessed remarkable participation from 28 teams, including representatives from the University of Nigeria and Eastern University, Bangladesh.

Over time, the event has been graced by several distinguished legal dignitaries, including former Chief Justices of India Dipak Misra and Altamas Kabir, Justice Shantanu Kemkar of the Bombay High Court, and Senior Advocate Joy Basu of the Supreme Court of India.

The eighth edition in 2019 upheld this tradition of excellence, inaugurated by Hon'ble Justice Rajiv Sahai and concluded by Justice Rohit Arya, attracting 44 teams and 274 participants from India and abroad.

In 2020, the ninth chapter was held virtually, drawing 165 teams including seven international

teams, and featured Salman Khurshid as chief guest for the inaugural ceremony and Justice Ashutosh J. Shastri of the Gujarat High Court for the valedictory.

The eleventh edition in December 2022 recorded massive participation, bringing together 150 teams from over 50 colleges, including delegates from Bangladesh, UK, UAE, Pakistan, Sri Lanka, and Nepal, alongside 14 National Law Universities and several leading private institutions. It was inaugurated by Chief Justice Ravi Malimath of the Madhya Pradesh High Court and concluded with Justice J.K. Maheshwari of the Supreme Court of India, while Hon'ble Vivek Singh, Co-Chairman of the State Bar Council of Madhya Pradesh, graced the valedictory ceremony.

In 2023, Lex Bonanza saw the participation of 55 teams and over 270 delegates from around the world, with the inaugural ceremony addressed by Justice Arvind Kumar of the Supreme Court of India and the valedictory by Justice Pranay Kumar Verma of the Madhya Pradesh High Court.

Lex Bonanza 2024 brought together 63 teams and over 250 participants from around the globe for a celebration of legal excellence. The inaugural ceremony featured addresses by Justice Virendra Singh, former Judge of the Madhya Pradesh High Court, and Mohan Sharma, Senior Advocate of the Supreme Court of India. The event concluded with a valedictory session led by Pradeep Rai, Senior Advocate of the Supreme Court of India, and Saurabh Bindal, Partner at Fox & Mandal. This year's Lex Bonanza solidified the Indore Institute of Law's commitment to promoting legal education and global collaboration.

Overview

Participating teams will argue for both sides during the preliminary rounds. Top 8 teams will proceed to the knock-out rounds for the Quarter-finals and Semi-finals, culminating in a

grand finale. Each round will challenge participants to present and defend their case with precision, professionalism, and acumen.

Eligibility:

Participation is open to bona fide undergraduate students of 5-year integrated B.A. LL.B. and 3-year LL.B. programme of a recognised University/College/Institution approved by the Bar Council of India.

Each college can send only one team of three members (two speakers and one researcher).

International Law Quiz Competition

Overview

Indore Institute of Law is organizing an International Law Quiz Competition under its flagship event Lex Bonanza 2k25. A Law Quiz Competition is an engaging academic event designed to test participants' knowledge, understanding, and awareness of various aspects of law and the legal system. It encourages critical thinking, quick recall, and analytical ability among students.

Competition Theme

The central focus of this competition will be on New Criminal Laws.

Team Composition and Representation

Composition: Each participating team must consist of three (3) participants.

Representation Limit: Each college is permitted to nominate only one team to represent their institution.

Competition Rounds: The competition will proceed through the following distinct stages:

Screening Round: A mandatory written examination lasting one (1) hour will be conducted to shortlist teams for the subsequent rounds.

Round I: A focused Question-Answer Round.

Round II: The Case Law Round, with a stipulated time limit of 30 minutes.

Round III: The Audio-Visual Round, structured as a Buzzer Round featuring 15 video/audio clippings.

Round IV: The final Rapid-Fire Round.

Round V: Audience Engagement Segment: A dedicated segment involving questions directed to the non-competing audience.

International Judgement Writing Competition

Overview

The International Judgement Writing Competition is an academic event aimed at enhancing participants understanding of judicial reasoning, legal interpretation, and drafting skills. It provides a platform for law students and young professionals across the globe to step into the role of a judge and craft reasoned judgements on complex legal issues.

Participants are typically presented with a hypothetical case problem based on contemporary or

emerging areas of law. They are required to analyze facts, apply legal principles, and deliver a well-reasoned, balanced, and coherent judgement in a prescribed format.

The competition encourages critical thinking, legal research, and analytical writing, while promoting a deeper understanding of judicial decision-making. By simulating real-world adjudication, it bridges the gap between theoretical knowledge and practical legal application, fostering excellence in legal scholarship on an international scale.

Theme	New Criminal Laws of India
Applicable Laws	The judgement must be exclusively based on the provisions of the following statutes, along with relevant case law: 1. Bharatiya Nyaya Sanhita (BNS), 2023 2. Bharatiya Nagarik Suraksha Sanhita (BNSS), 2023 3. Bharatiya Sakshya Adhinyam (BSA), 2023 and other criminal laws.
Jurisdiction	The judgement must be drafted as the final verdict of a Court of Sessions (Trial Court) in India.
Language	English & Hindi

Eligibility: The competition is open to all students pursuing a recognized undergraduate (3-year or 5-year) or postgraduate law degree (LL.M.) from any college/university recognized by the relevant national authority.

Competition Details

International Crime Scene Investigation Competition

Overview

The Crime Scene Investigation Competition offers law students an immersive, hands-on experience in forensic analysis and investigative reasoning. This unique challenge simulates a realistic crime scene where participants must analyse evidence, identify suspects, and draft a comprehensive investigation report under the theme of New Criminal Laws.

The competition bridges theoretical legal knowledge with practical investigative skills, providing participants with invaluable insights into how evidence is collected, analysed, and presented in modern criminal proceedings. Through careful observation, logical deduction, and collaborative teamwork, students will develop critical skills essential for criminal law practice while gaining practical understanding of investigative procedures under India's reformed criminal justice framework.

Event Date: November 14th, 2025

Team Composition

Each participating team must consist of exactly three members, all of whom must be currently enrolled law students (3-year or 5-year program). Team members will assume specific roles that mirror real investigative units:

Investigator - Leads evidence gathering and crime scene analysis.

Documenter - Maintains detailed records & photographic documentation

Analyzer - Synthesizes findings and formulates conclusions

Competition Format

Teams will navigate a two-phase challenge: a 15-minute intensive crime scene observation period followed by a 90-minute report compilation session. During observation, teams must identify and document all relevant evidence using only one mobile device for photography.

The subsequent reporting phase requires teams to produce a professional investigation report covering background analysis, evidence documentation, suspect hypothesis, and logical reasoning that demonstrates understanding of investigative methodology under the new criminal laws.

This competition develops essential legal skills including observation, critical analysis, documentation, and logical reasoning while providing practical exposure to criminal investigation procedures in a controlled, educational environment.

International Mediation Competition

Overview

This competition is designed to provide aspiring legal professionals with a platform to hone their skills in alternative dispute resolution. Participants will engage in simulated mediation sessions, stepping into the roles of counsel and client to resolve complex disputes. The event challenges participants to move beyond confrontational litigation and embrace collaborative problem-solving, strategic thinking, and effective communication. Judged by legal experts, this competition is an invaluable opportunity to gain practical experience in the essential art of mediation within a contemporary legal framework.

Theme: The theme for this year's competition is "Navigating Justice: Mediation and Negotiation under India's New Criminal Laws."

All competition problems will be centered on disputes arising from the application of India's transformative criminal legislation passed in 2023. Scenarios will explore the nuances of newly introduced concepts and offenses, such as corporate criminal liability under organized crime, plea bargaining the use of community service as a settlement tool, and disputes involving digital or economic crimes or any other concept. This theme will challenge participants to apply fresh legal principles to achieve

resolutions outside of a traditional courtroom trial.

Relevant Laws

Participants are expected to have a thorough understanding of the provisions and principles contained within India's new criminal legal framework:

The Bharatiya Nyaya Sanhita, 2023 (BNS)

The Bharatiya Nagarik Suraksha Sanhita, 2023 (BNSS)

The Bharatiya Sakshya Adhiniyam, 2023 (BSA)

The competition problems will be drafted based on the legal situations and procedures governed by these three acts and other laws.

International Debate Competition

Overview

The International Debate Competition is a prestigious platform that brings together students and young professionals from across the world to engage in intellectual exchange and critical dialogue on pressing global issues. It aims to foster public speaking, logical reasoning, and analytical thinking among participants while promoting cross-cultural understanding and respect for diverse perspectives.

Participants debate on a wide range of contemporary, legal, political, social, and ethical topics, often reflecting global challenges and current affairs. Through structured argumentation and persuasive communication, the competition nurtures participants' ability to articulate ideas confidently, think on their feet, and engage in respectful discourse — essential skills for future leaders, lawyers, and policymakers.

Topic: India's new criminal laws are more progressive than Western legal systems in addressing 21st-century crimes.

A debate is a structured, formal discussion on a specific topic where participants present opposing arguments to advocate for contrasting viewpoints.

Team Composition

Each team shall be composed of two speakers. One speaker will argue in favour of the motion (Proposition), and the other will argue against it (Opposition).

Competition Format

Each speaker will be allocated a total of four minutes to present their arguments. This time will be structured as follows:

1. 3 minutes for the main presentation.
2. 1 minute for a concluding remark or summation.

A warning bell will sound at the conclusion of the three-minute main presentation to signal that the speaker should begin their concluding remarks.

Arrival and On-Site Reporting

Mandatory Reporting: All teams are required to report to the Indore Institute of Law by 9:00 AM on Friday, November 14, 2025.

Arranged Transportation: For your convenience, the Institute will provide transportation from the railway station to the campus. The pick-up is scheduled for 08:00 AM on November 14, 2025.
