



MEDIATION PROBLEMS

The Mediation Problem will contain the General Problem-at-hand, privy to all the Participants, whereas the Confidential Information Exhibits or C.I.E. will contain Specially Drafted Factual & Confidential Information pertaining to each side (Requesting and Responding).

- The Confidential Information Exhibit (C.I.E.) for a Round shall be released i.e., revealed to the respective Negotiating Pair only (and not the Mediating Pair), exactly 30 minutes before their respective rounds in the rooms allotted for the same - C.I.E.R.S. (Confidential Information Exhibit Reading Station).
- The Confidential Information can be first used/disclosed by the Negotiating Pairs ONLY during the Caucus, not before. However, after the Caucus, the usage of the Confidential Information is allowed, at the discretion of the Negotiating Pairs.
- The Confidential Information is not mandatory to be used during a Round (at the time of the Caucus, and post-caucus) by the Negotiating Pairs. The usage shall be at their discretion, i.e., a Negotiating Pair may choose not to disclose their Confidential Information in their Caucus.



Release of the Mediation Problems

Mediation Problems will be released on 25th February 2026

There shall be a different Mediation Problem for each Round of Mediation i.e. separate problems in the Prelims I, Prelims II, Quarter-Finals, Semi-Finals & The Final Round, and 2 different Confidential Information Exhibits (C.I.E.) each, for the Requesting and Responding Side respectively, for the Participants to get acquainted with the Problems well in advance, and form their arguments and contentions accordingly, in the adequate time-frame before the Competition.

COMPETITION FORMAT

CLAUSE I - COMPETITION ROUNDS & QUALIFICATION CRITERIA

A. Preliminary Rounds (Prelims I & II)

All the Participating Teams shall appear twice in the Preliminary Rounds - once from the Requesting, once from the Responding Side, in the Prelims I & II - as per the sides allotted to them via the Draw of Lots. The Negotiating Pair of each Team - consisting of the Client & the Counsel - will be marked together as one unit, while the Mediator of each team shall be marked separately from that team's Negotiating Pair. Therefore, after the Preliminary Rounds, the Top 8 Mediators and the Top 8 Negotiating Pairs (Client-Counsel), with the highest cumulative (average) scores from both the Prelims (I & II), will advance to the Quarter-Finals. There shall be a Slot System in the Preliminary Rounds, i.e. the Teams will be allotted slots for their Mediation Rounds via the Draw of Lots, in Preliminary Rounds, I & II. In the Quarter Finals, the Qualifying Negotiating Pairs will be allotted a side to represent - Req. or Res. (as per the subsequent Draw of Lots for the Quarter-Finals).

B. Quarter-Finals (QF)

The Quarter-Final Round will be a Knockout Round, i.e., in this round, out of the two Negotiating Pairs and two Mediators in each Mediation Room, only one Negotiating Pair and one Mediator, getting more marks than the counter-participant(s), shall qualify for the Semi-Final Round. Therefore, out of the 8 Mediators and 8 Negotiating Pairs in the Quarter-Finals, 4 Mediators and 4 Negotiating Pairs shall qualify to the Semi-Finals.

The marks of the Quarter-Final Round shall be exclusive of the Scores obtained in the Preliminary Rounds.

All the sessions (65 minutes) in the Quarter Finals will be held parallelly.

C. Semi-Finals (SF)

The Semi-Final Rounds will also be a Knockout Round (similar to Quarter-Finals).

Therefore, out of the two Negotiating Pairs and Mediators in each Mediation Room, only one Negotiating Pair and one Mediator, getting more marks than the counter-participant(s), shall qualify to the Final Round of XMC'26.

The marks of the semi-final rounds shall be exclusive of the Scores obtained in the Preliminary & Quarter-Final Rounds.

All the sessions (70 minutes) in the Semi-Finals will be held parallelly.

D. The Final Round

The qualifying participants from the Semi-Final Round i.e. 2 Mediators & 2 Negotiating Pairs will appear for the Final Round of XMC'26 - and the winners shall be adjudged on the basis of the scores given by the Judges.

IMPORTANT FACTS TO BE KNOWN:

1. The mediator of a team shall not be paired with his/her own team in any of the Prelims (I & II) - i.e. the Mediator of a Team will be a competing unit, separate from the Negotiating Pair (Attorney & Client) of the same team, hence there shall be no Team-Wise Marking. Therefore, there may be cases, wherein the Mediator of a Team qualifies for the other rounds, but the Negotiating Pair of the same team does not - or vice versa.
2. The Mediating Pair (consisting of two mediators from two different teams) in the rounds will be marked individually - and not as a Pair. The Mediators will advance individually, i.e. irrespective of their Team or Pair in a round.
3. The Client & the Counsel in a Negotiating Pair, however, will be marked together as a Pair - hence the Negotiating Pairs will not be changed throughout the duration of the Competition - and will advance together as a pair.

Random Pairing Post-Prelims: In the Preliminary Rounds (I & II), the Mediator from a Team will - under no circumstance - be paired with the Negotiating Pair of the Same Team. But in the Quarter-Finals, Semi-Finals & the Final Round - the allotments can be random, and such a case may arise where a qualifying Mediator and a qualifying Negotiating Pair belong to the same team, and they are grouped together.

CLAUSE II - MARKING SCHEMES

I. MARKING SCHEME FOR THE MEDIATOR

1. Opening Statement

Effective explanation of the process of mediation, the role of the mediators, the code of conduct and any other significant aspect.

2. Confidentiality

Maintenance of the confidentiality of both the parties' confidential information. The ability to balance the strengths, weaknesses, contrasting interests and needs of the parties, during the Session.

3. Time Management

Adherence to the prescribed time limit in the Session.

4. Co-Operation

Co-ordination and facilitation between the Mediators, throughout the round. Understanding the points put forth by the negotiating pairs and helping them arrive at a productive solution or arrangement.

5. Tackling

Employing techniques of active listening.
Being neutral and non-judgmental to defuse conflict.

6. Dress Code

Adherence to proper Dress Code (Law Formals - Black Blazer, Black Trousers, White Shirt, Black Tie & Black Shoes).

II. MARKING SCHEME FOR THE COUNSEL

1. Opening Statement

Awareness of factual knowledge and identification of issues arising out of the facts. Properly dealing with technicalities, and details pertaining to the facts.

2. Utilization of C.I. (Confidential Information)

Disclosure and beneficial use of confidential information.

3. Co-Operation

Teamwork between client and counsel for effective communication between the two as well as in order to avoid any role-overlap.

4. Attorney Skills

Backing up the client's demand during the presentation of offers through legal validations. Strategizing to arrive at a reasonable and effective solution, balancing the client's interests and effective utilization of time.

5. Negotiation

Ensuring legitimacy of persuasion methods and a convincing attitude. Guiding the client to use leverages appropriately to arrive at a reasonable and realistic solution that suits the parties.

6. Dress Code

Adherence to proper Dress Code (Law Formals - Black Blazer, Black Trousers, White Shirt, Black Tie & Black Shoes).

III. MARKING SCHEME FOR THE CLIENT

1. Opening Statement

Proper knowledge of the facts and an articulate presentation of the same. Clarity of stance and expectations for settlement to be duly expressed.

2. Utilization of C.I. (Confidential Information)

Disclosure and beneficial use of confidential information.

3. Co-Operation

Teamwork between client and counsel for effective communication between the two as well as in order to avoid any role-overlap.

4. Conduct

A formal and proper conduct with a respectable and patient demeanour to keep the environment secure and to avoid hostility. Effective utilization of time, along with a degree of self-control against manipulative and inciting tactics deployed by members of the opposing parties.

5. Negotiation

Rigidity of stance, and flexibility of negotiating positions. Use of collaborative and reasonable measures while engaging in a problem-solving search for sensible and inventive solutions.

6. Dress Code

Adherence to proper Dress Code (Law Formals - Black Blazer, Black Trousers, White Shirt, Black Tie & Black Shoes).

TEAM REGISTRATIONS

CLAUSE I - ELIGIBILITY CRITERIA FOR TEAM REGISTRATIONS

A. Territory, Recognition & Course:

For Domestic Students, any student pursuing any three-year or five-year integrated courses of the LL.B. degree from any Law School/College/University/Institution recognized by the Competent Authority are eligible to participate (Students pursuing the LL.M. degree are also eligible to participate). For International Students, any student pursuing any law degree which is recognized by the competent authority are eligible to participate.

B. Semester/Year:

Students from any Year/Semester can form/join a Team and register for participation. Cross-Semester Participation is allowed, i.e., a Team may consist of students from different semesters/years, however, the college/university must be the same.

Closure of Registrations on reaching Intake Capacity: The Organizing Committee reserves the right to disable the Google Form once the Maximum Intake Capacity is reached - confirmed on first-come-first-serve basis (only).

Maximum No. of Teams permitted from a University/College is Two (2).

CLAUSE II - DETAILED PROCESS FOR TEAM REGISTRATIONS

A. Bona Fide Certificate

Students can form Teams - as per the Eligibility Criteria - and obtain a Bona-Fide Certificate from their respective Law School/College/University/Institution, attesting & affirming the participation of that team in XMC'26, which should compulsorily contain the following:-

1. Official Logo/Seal of the University/College/School /Institution
2. Names of the Students of the Participating Teams
3. Acknowledgement of their Participation in XMC'26 as a Team

B. Payment of Team Registration Fees

Each domestic team consisting of the Mediator, Client & Counsel, is required to pay the Team Registration Fees of INR 5,400. The registration fees for international teams belonging to SAARC nations will be USD 70 & that for teams from countries other than SAARC nations will be USD 110 through any of the Payment Gateways. Once the registration fees amount is transferred, the Teams are required to take a Screenshot/Scanned Copy of the Payment Receipt generated, or the Bank Slip - in order to attach it in the Google Form.

(Does not include Accommodation Fees)

C. Submission of Team Registration Form

After the Fees Transaction, the team has to fill and submit the Google Form for XMC'26 Team Registrations - (hyperlink attached below). In the Google Form, the following details and attachments will be required:-

 - Name, Course, Semester, Email ID and Phone No. (preferably WhatsApp Enabled)

4. Scanned Copy of the Bona-Fide Certificate **PDF**
5. Scanned Copy of the Payment Receipt of the Registration Fees **PDF**

D. Confirmation of Registration

Once the form is received by the Organizing Committee, a mail - confirming the registration of the Team - will be sent (in no fixed timeframe), after the verification of the documents attached and payment of the Team Registration Fees.

Alteration in Roles Post-Registration: The roles cannot be changed after the Confirmation of Registration. Any requested change shall be completely at the discretion of the Organizing Committee.

Note: The Home Team from XLS, SXUK - shall also be a part of the Competition.

RULES & REGULATIONS

Given below are certain important Rules & Regulations - mandatory for every Participant to comply with.¹

CLAUSE I - TEAM COMPOSITION & TEAM CODE

A. Team Members & their Roles

Each team shall mandatorily consist of 3 members. This number cannot be modified under any circumstances. There shall be 1 Mediator, 1 Counsel and 1 Client. The roles will not be subject to any change after the confirmation of the team's registration.

B. Team Codes

Each team shall be allotted a unique team code. Teams should not disclose their identity or that of their institution, etc., under any circumstances and such disclosure shall invite penalties including disqualification from the Competition directly. The decision for the same shall be at the discretion of the Organizing Committee.

CLAUSE II - DRESS CODE²

- Law Formals (Black Suit, Black Trousers, Black Tie, Black Shoes and White Shirt)
- The dress code is same and compulsory for all the participants, and they are expected to make their own arrangements regarding the same.

CLAUSE III - MAINTENANCE OF ANONYMITY

A. Anonymity

The Participants may introduce themselves to the Judges in the usual manner and are also required to state their respective team code. However, the team's college name shall not be indicated to the judges at any time.

B. Neutral Identification

Further, all team members shall refrain from identifying a team's law school/college/university at any time and in any manner, including but not limited to wearing any identifying items (such as college clothing, ties, patches or pins) or carrying identifying material (such as books with a college logo or seal etc.).

D **Discretion Clause** - Subject to the Complete Discretion of the Organizing Committee.

N **Non-Compliance Clause** - Non-Compliance with the guidelines laid down may result in Negative Marking and/or Direct Disqualification (Subject to the Discretion of the Organizing Committee)

C. ID Card Verification

Participants must carry their College/University/Institution Identity Card (ID Card) & also the Bona-Fide for the purpose of Offline Verification during the competition.

CLAUSE IV - CODE OF CONDUCT

A. Scouting

Teams will not be allowed to observe the rounds of any of the other teams. Scouting is strictly prohibited.^N

B. Language

The Participants are directed to use only English Language during the Competition.

C. Prohibition on use of Mobile Phones & Electronic Gadgets

Use of mobile phones or any other electronic device (Eg.: Smart Watch) is strictly prohibited during the competition, in between the Rounds at the M.R.s, and during the C.I.E. Reading Time, at the C.I.E.R.S. The Team Members will be required to hand their phones over to the Team Representatives allotted to the Teams (by the Organizing Committee) before their C.I.E. Reading Time begins, and shall obtain it back from them at the end of their respective Mediation Round (in all levels).

D. Prevention of Unethical Means

The display of any other unethical/unprofessional conduct is strictly prohibited.

E. Prohibition on Revelation of Confidential Information (C.I.)

It is strictly prohibited for anyone to share/reveal any detail pertaining to or even closely related to the Confidential Information, outside their respective Mediation Sessions. The mediators shall have no access to the confidential information of any of the parties, apart from their own Caucus Rounds. Non-compliance may lead to direct disqualification of the Team.^N

D **Discretion Clause** - Subject to the Complete Discretion of the Organizing Committee.

N **Non-Compliance Clause** - Non-Compliance with the guidelines laid down may result in Negative Marking and/or Direct Disqualification (Subject to the Discretion of the Organizing Committee)

CLAUSE V - CREATION OF EXTRANEOUS FACTS

The creation of extraneous facts is not permitted and the teams shall be penalized for the same. However, the teams may reasonably interpret the problem to draw reasonable conclusions.

CLAUSE VI - PROCEDURAL RULES & GUIDELINES

Note: There is no provision for cross-caucus. "Cross-Caucus" refers to a separate meeting between the Mediators and both Counsellors or a separate meeting between the Mediators and both Clients.

- The "feedback" shall be provided to the teams by the Judges of the respective rounds.
- The term "Caucus" shall refer to a private meeting between the Mediators and a Negotiating Pair (Client & Counsel). A Caucus is called for the Teams to take input from the Mediators or for when there is some Confidential Information that they are not comfortable sharing during the Joint Session. The Caucus is mandatory to be called by the Mediators/Negotiating Pairs at the time mentioned as per the Time Distribution. Usage of Caucus Time by Negotiating Pairs: Minimum: 1 minute, Maximum: 5 minutes.
- The Mediators must ask the Negotiating Pairs (during/after the caucus) before bringing up or discussing/revealing their side's Confidential Information in the post-caucus session.

CLAUSE VII - AMENDMENT OF RULES

Amendment Powers of the Organizing Committee

The Organizing Committee of XMC'26 reserves all rights & powers to amend any rule/guideline/provision mentioned in this Brochure.

- D** *Discretion Clause* - Subject to the Complete Discretion of the Organizing Committee.
- N** *Non-Compliance Clause* - Non-Compliance with the guidelines laid down may result in Negative Marking and/or Direct Disqualification (Subject to the Discretion of the Organizing Committee)
